HOUSE CONCURRENT RESOLUTION NO. 77

CIVIL SERVICE/COMMISSION: Requests the State Civil Service Commission to provide a mechanism for placing employees in a specified situation on a preferred reemployment list

A CONCURRENT RESOLUTION

2	To urge and request the State Civil Service Commission to adopt a rule to allow state
3	employees whose jobs are privatized or whose jobs are relocated to another parish
4	more than fifty miles from the previous work location to be placed on a preferred
5	reemployment list.
6	WHEREAS, an increasing number of classified state employees are being placed in
7	a position where their jobs are either being privatized or their jobs are relocated to another
8	parish more than fifty miles from the previous work location, and rather than being laid off,
9	their jobs are either eliminated or moved to a location to which the employees may find it
10	difficult or impossible to relocate in a short period of time; and
11	WHEREAS, experienced employees contribute a breadth of knowledge and stability
12	to the workplace; and
13	WHEREAS, the benefit of retaining experienced, well-performing state employees
14	combined with the high cost of training new employees makes it sensible and desirable to
15	give preference to employees whose jobs are privatized or whose jobs are relocated to
16	another parish more than fifty miles from the previous work location.
17	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
18	urge and request the State Civil Service Commission to adopt a rule to allow state employees
19	whose jobs are privatized or whose jobs are relocated to another parish more than fifty miles
20	from the previous work location to be placed on a preferred reemployment list.
