## SCHOOLS/CHARTER: Provides relative to requirements for the recruiting, employing, and training of charter school employees

2	To amend and reenact R.S. 17:3996(C), relative to charter schools; to provide relative to the
3	recruiting, employing, and training of charter school employees without regard to
4	race, color, religion, sex, or national origin; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 17:3996(C) is hereby amended and reenacted to read as follows:
7	§3996. Charter schools; exemptions; requirements
8	* * *
9	C.(1) A charter school established and operated in accordance with the
10	provisions of this Chapter shall comply with state and federal laws and regulations
11	otherwise applicable to public schools with respect to civil rights and individuals
12	with disabilities.
13	(2) A charter school established and operated in accordance with the
14	provisions of this Chapter shall accordingly recruit, employ, and train teachers,
15	administrators, and other employees without regard to race, color, religion, sex, or
16	national origin. Race, color, religion, sex, and national origin shall not constitute
17	bona fide occupational qualifications. Proficiency in a foreign language may
18	constitute a bona fide occupational qualification for a teacher who spends more than
19	half of his daily instruction time providing instruction in or teaching in a foreign
20	language.

HB No. 1282

Abstract: Provides for the recruiting, employing, and training of charter school employees without regard to race, color, religion, sex, or national origin.

<u>Present law</u> provides generally for exemptions and requirements for charter schools including a requirement that charter schools comply with state and federal laws and regulations otherwise applicable to public schools with respect to civil rights and individuals with disabilities. <u>Proposed law</u> adds a requirement that a charter school recruit, employ, and train employees without regard to race, color, religion, sex, or national origin. Specifies that race, color, religion, sex, and national origin shall not constitute bona fide occupational qualifications. Provides that proficiency in a foreign language may constitute a bona fide occupational qualification for a teacher who spends more than half of his daily instruction time providing instruction in or teaching in a foreign language.
