| 11 | the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950. |
| 12 | Section 2. Notwithstanding any provision of any previous Act of the legislature, all |
| 13 | statutory authority for the existence of the Department of Public Service and the statutory |
| 14 | entities made a part of the Department of Public Service, as re-created under the provisions |
| 15 | of Section 1 of this Act, shall cease as of July 1, 2019, pursuant to R.S. 49:191. However, |
| 16 | the Department of Public Service and the statutory entities made a part of the Department |
| 17 | of Public Service may be re-created prior to such date in accordance with the provisions of |
| 18 | Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950. |
| 19 | Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent those |
