1 AN ACT 2 To amend and reenact R.S. 17:3048.1(A)(1)(f)(introductory paragraph) and (iv), relative to 3 the Taylor Opportunity Program for Students; to provide relative to the high school 4 core curriculum required for initial eligibility for a program award; and to provide 5 for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 17:3048.1(A)(1)(f)(introductory paragraph) and (iv) are hereby 8 amended and reenacted to read as follows: 9 §3048.1. Program awards; eligibility; amounts; limitations; funding; administration 10 A.(1) As part of the Louisiana Taylor Opportunity Program for Students, the 11 state shall financially assist any student who enrolls on a full-time basis in a public 12 college or university in this state or a regionally accredited independent college or 13 university in the state that is a member of the Louisiana Association of Independent 14 Colleges and Universities, hereafter in this Chapter referred to collectively as 15 "eligible colleges and universities", to pursue an academic undergraduate degree or, 16 as provided by this Subsection, skill or occupational training as defined by the Board 17 of Regents, including a vocational or technical education certificate or diploma 18 program or a nonacademic undergraduate degree, and who meets the qualifications 19 of Subparagraph (b), (c), or (d) of this Paragraph and all of the applicable following 20 qualifications:

Thompson HB No. 1115

Abstract: Provides that certain Advanced Placement ½-unit courses shall "count" for one unit for purposes of the high school core curriculum that students must complete to be eligible for Taylor Opportunity Program for Students (TOPS) awards.

<u>Present law</u> provides for the Taylor Opportunity Program for Students (TOPS) as a program of merit scholarships for students attending certain postsecondary education institutions who meet specific grade point average, ACT score, and core curriculum requirements and certain other qualifications. Provides that students graduating from high school during the 2017-2018 school year and thereafter, in addition to meeting other eligibility requirements, must successfully complete 19 units of specified course work that constitutes a core curriculum, including four units in social studies. (See table.)

<u>Proposed law</u>, for a student who completes a ½-unit Advanced Placement (AP) Government and Politics course, reduces the total number of required core curriculum units <u>from</u> 19 to 18.5, and the total number of social studies units <u>from</u> four <u>to</u> 3.5 by revising the social studies requirements as follows:

Two units chosen from the following: Western Civilization, European History, or AP European History; World Geography, AP Human Geography, or IB Geography; World History, AP World History, or World History IB; History of Religion; IB Economics.	Retains <u>present law</u> .
