

HOUSE COMMITTEE AMENDMENTS

Amendments proposed by House Committee on Transportation, Highways, and Public Works to Engrossed Senate Bill No. 582 by Senator Claitor

AMENDMENT NO. 1

On page 1, line 2, after "R.S." delete the remainder of the line and delete lines 3 through 8 in their entirety and insert the following:

"32:412(A)(1),(2), (3), (4)(a) and introductory paragraph of (b), (5), (6), (7)(a) and introductory paragraph of (b), (B)(1), (2), (5), (7)(a)(i) and introductory paragraph of (ii), (b)(i) and introductory paragraph of (ii), (c)(i) and introductory paragraph of (ii), (d)(i) and introductory paragraph of (ii), (e)(i)(aa), introductory paragraph of (bb), (cc), (dd), and (ee), and (ii)(aa), (bb), (cc), (dd), and (ee) and (C), 32:412.1(B),(C),(D), and 32:429(A), to enact R.S. 32:412.1(E) and 412.3, and to repeal R.S. 32:412.1(A)(1), relative to the duration of driver's licenses; to provide that driver's licenses be renewed every six years; to provide for fees; to provide for the distribution of revenue; to create and provide for special funds; and to provide for related matters."

AMENDMENT NO. 2

On page 1, line 10, after "R.S." delete the remainder of the line and delete lines 11 through 14 in their entirety and insert the following:

"32:412(A)(1),(2),(3),(4)(a) and introductory paragraph of (b), (5), (6), (7)(a) and introductory paragraph of (b), (B)(1), (2), (5), (7)(a)(i) and introductory paragraph of (ii), (b)(i) and introductory paragraph of (ii), (c)(i) and introductory paragraph of (ii), (d)(i) and introductory paragraph of (ii), (e)(i)(aa), introductory paragraph of (bb), (cc), (dd), (ee), and (ii)(aa), (bb), (cc),(dd), and (ee) and (C), 32:412.1(B)(C)(D), and 32:429(A) are hereby amended and reenacted and R.S. 32:412.1(E) and 412.3 are hereby enacted to read as"

AMENDMENT NO. 3

On page 2, line 2, after "A." delete the remainder of the line in its entirety and insert the following:

(1) Every applicant for a Class "D" driver's license, or for a renewal of a Class "D" driver's license, except those bona fide residents of the city of New Orleans, shall pay for such basic license a fee of ~~twenty-eight dollars and fifty cents~~ **forty-two dollars and seventy-five cents**. ~~Seven dollars and forty three cents~~ **Eleven dollars and fifteen cents** of the fee shall be paid to the State Police Pension and Retirement Fund. One dollar **and fifty cents** of the fee shall be forwarded by the department to the litter abatement and education account which is created with the Conservation Fund through the provisions of R.S. 56:10(B)(15).

(2) The fee for Class "D" driver's licenses, or renewal of a Class "D" driver's license, issued to bona fide residents of the city of New Orleans shall be ~~thirty-six dollars~~ **fifty-four dollars**, ~~ten dollars~~ **fifteen dollars** of which shall be payable by the department to the board of trustees of the police pension fund of the city of New Orleans. One dollar and ~~twenty three cents~~ **eighty four cents** of the fee shall be paid to the State Police Pension and Retirement Fund. One dollar **and fifty cents** of fee shall be forwarded by the department to the litter abatement and education account which is created within the Conservation Fund through the provisions of R.S. 56:10(B)(15).

1 (3) There shall be a fee of ~~five dollars~~ **seven dollars and fifty cents** for an
 2 emergency vehicle endorsement for any vehicle group."

3 AMENDMENT NO. 4

4 On page 2, delete line 11 in its entirety and insert the following:

5 "(5) Every applicant for a Class "E" driver's license, or for a renewal of a
 6 Class "E" driver's license, except those bona fide residents of the city of New
 7 Orleans, shall pay for such basic license a fee of ~~thirteen dollars and fifty cents~~
 8 **twenty dollars and twenty-five cents**, which shall be the cost of such basic license.
 9 ~~Three dollars and seventy-five cents~~ **Five dollars and sixty-three cents** of the fee
 10 shall be paid to the State Police Pension and Retirement Fund. One dollar **and fifty**
 11 **cents** of the fee shall be forwarded by the department to the litter abatement and
 12 education account which is created within the Conservation Fund through the
 13 provisions of R.S. 56:10(B)(15).

14 (6) The fee for a Class "E" driver's license, or renewal of a Class "E" driver's
 15 license, issued to bona fide residents of the city of New Orleans shall be ~~thirteen~~
 16 ~~dollars and fifty cents, two dollars and fifty cents~~ **twenty dollars and twenty-five**
 17 **cents, three dollars and seventy-five cents** of which fee shall be paid by the
 18 department to the board of trustees of the police pension funds of the city of New
 19 Orleans. ~~Two dollars and fifty cents~~ **Three dollars and seventy-five cents** of the fee
 20 shall be paid to the State Police Pension and Retirement Fund. One dollar **and fifty**
 21 **cents** of the fee shall be forwarded by the department to the litter abatement and
 22 education account which is created within the Conservation Fund through the
 23 provisions of R.S. 56:10(B)(15)."

24 AMENDMENT NO. 5

25 On page 2, line 21, after "B." delete the remainder of the line in its entirety and insert the
 26 following:

27 "(1) Every applicant for a Class "A", "B", or "C" commercial driver's license,
 28 or for a renewal of a basic Class "A", "B", or "C" commercial driver's license, except
 29 for those bona fide residents of the city of New Orleans, shall pay for such basic
 30 license a fee of ~~forty-one dollars. Ten dollars and eighty cents~~ **sixty-one dollars and**
 31 **fifty cents. Sixteen dollars and twenty cents** of the fee shall be paid to the State
 32 Police Pension and Retirement Fund. One dollar **and fifty cents** of the fee shall be
 33 forwarded by the department to the litter abatement and education account which is
 34 created within the Conservation Fund through the provisions of R.S. 56:10(B)(15).

35 (2) The fee for a basic Class "A", "B", or "C" commercial driver's license, or
 36 for the renewal of a basic Class "A", "B", or "C" commercial driver's license, issued
 37 to bona fide residents of the city of New Orleans shall be ~~fifty one dollars, ten~~
 38 **seventy-six dollars and fifty cents, fifteen dollars** of which fee shall be paid by the
 39 department to the board of trustees of the police pension fund of the city of New
 40 Orleans. ~~Ten~~ **Fifteen** dollars of the fee shall be paid to the State Police Pension and
 41 Retirement Fund. One dollar **and fifty cents** of the fee shall be forwarded by the
 42 department to the litter abatement and education account which is created with the
 43 Conservation Fund through the provisions of R.S. 56:10(B)(15).

45 (5) There shall be a fee of ~~five dollars~~ **seven dollars and fifty cents** for each
 46 endorsement to the basic licenses listed in R.S. 32:408(B).

 49 **dollars and seventy-five cents**"

2 On page 4, delete line 19 in its entirety and insert the following:

3 "(cc) ~~Fifty cents~~ **Seventy-five cents** of the fee shall be paid to the office of
 4 state police. ~~One dollar and fifty cents~~ **Two dollars and seventy-five cents** of the
 5 fee shall be paid to the State Police Pension and Retirement Fund. One dollar **and**
 6 **fifty cents** of the fee shall be forwarded by the department to the litter abatement and
 7 education account which is created within the Conservation Fund through the
 8 provisions of R.S. 56:10(B)(15)."

9 AMENDMENT NO. 8

10 On page 4, line 22, after "fee of" delete "fourteen" and at the beginning of line 23, delete
 11 "dollars and seventy-five cents" and insert "**twenty-two dollars and thirteen cents**"

12 AMENDMENT NO. 9

13 On page 5, delete line 6 in its entirety and insert the following:

14 "(ee) ~~Three dollars and seventy-one cents~~ **Five dollars and fifty-six cents** of
 15 the fee shall be paid to the State Police Pension and Retirement Fund. One dollar **and**
 16 **fifty cents** of the fee shall be forwarded by the department to the litter abatement and
 17 education account which is created within the Conservation Fund through the
 18 provisions of R.S. 56:10(B)(15)."

19 AMENDMENT NO. 10

20 On page 5, at the end of line 9 delete "four" and on line 10, delete "dollars and fifty cents"
 21 and insert "**six dollars and seventy-five cents**"

22 AMENDMENT NO. 11

23 On page 5, delete line 22 in its entirety and insert the following:

24 "(cc) One dollar **and fifty cents** of the fee shall be paid to the Board of
 25 Trustees of the Police Pension Fund of the city of New Orleans. One dollar **and fifty**
 26 **cents** of the fee shall be paid to the State Police Pension and Retirement Fund. One
 27 dollar **and fifty cents** of the fee shall be forwarded by the department to the litter
 28 abatement and education account which is created within the Conservation Fund
 29 through the provisions of R.S. 56:10(B)(15)."

30 AMENDMENT NO. 12

31 On page 5, at the beginning of line 26, delete "eighteen dollars and fifty cents" and insert
 32 "**twenty-seven dollars and seventy-five cents**"

33 AMENDMENT NO. 13

34 On page 6, between lines 8 and 9, insert the following:

35 "(ee) ~~Five dollars~~ **Seven dollars and fifty cents** of the fee shall be payable
 36 by the department to the board of trustees of the police pension fund of the city of
 37 New Orleans. ~~Sixty-one cents~~ **Ninety-two cents** of the fee shall be paid to the State
 38 Police Pension and Retirement Fund. One dollar **and fifty cents** of the fee shall be
 39 forwarded by the department to the litter abatement and education account which is
 40 created within the Conservation Fund through the provisions of R.S. 56:10(B)(15)."
