5	WHEREAS, Dr. Frank Riddick holds his undergraduate and medical degrees from
6	Vanderbilt University, where he was a member of Kappa Sigma fraternity, Phi Chi medical
7	fraternity, and elected to Phi Beta Kappa and to Alpha Omega Alpha Honor Medical
8	Society; and
9	WHEREAS, Dr. Riddick furthered his medical education in internal medicine and
10	endocrinology at the Barnes Hospital-Washington University Complex in St. Louis,
11	Missouri; and
12	WHEREAS, he also attended the Program in Health Systems Management at the
13	Harvard University Graduate School of Business Administration; and
14	WHEREAS, Dr. Riddick spent his entire career as both a doctor and administrator
15	in Ochsner Health System affiliated institutions, and held positions as head of the Section
16	of Endocrinology and Metabolic Diseases, medical director and chief executive officer of
17	the Ochsner Clinic, chief executive officer of the Alton Ochsner Medical Foundation, and
18	chief executive officer emeritus of the Ochsner Health System; and

1	WHEREAS, during Dr. Riddick's twenty-six years of leadership with Ochsner	
2	institutions, the professional staff quintupled in size to over five hundred physicians, and the	
3	health maintenance organization now has two hundred twenty-five thousand subscribers; and	
4	WHEREAS, nationally, Dr. Riddick has served as past president of the American	
5	College of Physician Executives, the American Group Practice Association, and the Society	
6	of Medical Administrators, and chair of the American Medical Association's Council on	
7	Medical Education and Council on Judicial and Ethical Affairs, while also obtaining the	
8	distinction of Master of the American College of Physicians, the American College of	
9	Endocrinology, as well as being designated a Distinguished Fellow of the American College	
10	of Physician Executives; and	
11	WHEREAS, Dr. Riddick has also served his community as a professor of clinical	
12	medicine at the Tulane University School of Medicine; and	
13	WHEREAS, Dr. Riddick served his country with active duty in the United States	
14	Army Medical Corps from 1955 through 1957 with the rank of captain and continued to	
15	serve in the United States Army Reserves until 1963, achieving the rank of major; and	
16	WHEREAS, Dr. Riddick has served his faith community as a Vestryman of Trinity	
17	Episcopal Church in New Orleans; and	
18	WHEREAS, Dr. Riddick is the beloved husband of Mary Belle Alston Riddick, as	
19	well as a beloved and revered father and grandfather; and	
20	WHEREAS, during his tenure as the medical director and chief executive officer of	
21	the Ochsner Clinic, then-state representative and later state senator Leonard J. Chabert	
22	approached Dr. Riddick about the possibility of having Ochsner staff the South Louisiana	
23	Medical Center charity hospital then under construction in Houma, Louisiana; and	
24	WHEREAS, Dr. Riddick saw this opportunity as mutually beneficial to Ochsner and	
25	its physician group, the Bayou Region, its indigent and working poor of the area, and agreed	
26	to staff the hospital; and	
27	WHEREAS, in response to this calling, Dr. Riddick formed the South Louisiana	
28	Medical Associates, an Ochsner-affiliated physician group to service the hospital; and	
29	WHEREAS, the bond between Senator Chabert and Dr. Riddick was instrumental	
30	in the launch of this new charity hospital and its unique public-private management
