34	(c) The fitness for entrance and promotional tests administered by the state examiner
35	pursuant to this Paragraph shall be of the same type and format as the tests administered by

- 1 the state examiner for classified employees in other jurisdictions. Tests shall be developed
- 2 for the fire service in cities subject to the provisions of this Paragraph in the same manner
- 3 as they are developed for other municipal fire departments supported by the state examiner.
- 4 (d) All examination materials developed by the state examiner shall remain at all 5 times in the custody of the state examiner.
- 6 (e) The state examiner shall not be required to administer more than a total of four
- fitness for entrance or promotional tests for a city civil service commission pursuant to this
 Paragraph in any twelve-month period."
