5	Be it enacted by the Legislature of Louisiana:			
6	Section 1. R.S. 32:1261(A)(1)(t) is hereby amended and reenacted to read as			
7	follows:			
8	\$1261. Unauthorized acts			
9	A. It shall be a violation of this Chapter:			
10	(1) For a manufacturer, a distributor, a wholesaler, distributor branch, factory			
11	branch, converter or officer, agent, or other representative thereof:

13	(t) To operate a satellite warranty and repair center, to authorize a person to			
14	perform warranty repairs who is not a motor vehicle dealer, or to authorize a motor			
15	vehicle dealer to operate a satellite warranty and repair center within the community			
16	or territory of a same-line or make motor vehicle dealer. This Subparagraph shall not			
17	apply to recreational any of the following:			
18	(i) Recreational product manufacturers.			
19	(ii) Emergency service of a vehicle.			
20	(iii) A fleet owner or governmental entity that is authorized to perform			
21	warranty repairs on any of the following motor vehicles owned or leased by the			
22	fleet owner or governmental entity:			
23	(aa) Those with a gross vehicle weight rating of twelve thousand pounds

2	(iv) The dealer that sold the motor vehicles listed in Item (iii) of this
3	Subparagraph to the fleet owner or governmental entity may and a
4	manufacturer that authorized the fleet owner or governmental entity to
5	perform warranty repairs on the motor vehicles described in Item (iii) of this
6	Subparagraph shall give notification of the authorization to the dealer located
7	in the same community or territory where the fleet owner or governmental
8	entity intends to perform the authorized warranty repairs. The notification
9	shall include the type of warranty repairs authorized by the manufacturer.
10	(v) A fleet owner or governmental entity performing warranty repairs

## VETO MESSAGE

"Senate Bill No. 318 by Senator Gary Smith, Jr., provides for exceptions to the law that prohibits a motor vehicle dealer from authorizing a person who is not a motor vehicle dealer to perform warranty repairs.

While the bill as filed presented a narrow exemption for owners of fleet vehicles to do limited warranty work, the bill was amended. Dozens of legislators in both the House and Senate have expressed concerns about the unintended consequences of these amendments that they did not realize when they voted on the bill, and have asked me to veto it as a result.

In addition, the Louisiana Automobile Dealers Association, as well as dealerships across the state, have also asked for a veto. I am concerned that the stakeholders did not have sufficient opportunity to give their input during the development of the bill and that legislators should have the chance to consider the implications.

For these reasons, I have vetoed Senate Bill No. 318 and hereby return it to the Senate."
