(Constitutional Amendment) Requires that monies received by the state from violations of certain federal and state laws associated with the Deepwater Horizon oil spill be deposited into the Coastal Protection and Restoration Fund

Provides for a constitutional amendment to be submitted to voters at the November 4, 2014 election that requires any state monies received from violations of the Federal Water Pollution Control Act, the Louisiana Environmental Quality Act, and the Louisiana Water Control Law associated with the Deepwater Horizon oil spill be deposited into the Coastal Protection and Restoration Fund for integrated coastal protection efforts, including coastal restoration, hurricane protection and improving the resiliency of the Louisiana coastal area affected by the Deepwater Horizon oil spill. The enabling legislation is Act 805 of 2012.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The proposed constitutional amendment will be considered by voters at the statewide election to be held on November 4, 2014. The Secretary of State may incur minimal ballot printing costs associated with this measure. However, as a regular practice, the Secretary of State typically budgets for up to 10 constitutional amendments for the fall statewide elections.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. The enabling legislation, Act 805 of 2012, provides for dedication of the revenue to the Coastal Protection and Restoration Fund.

NOTE: The Department of Public Safety currently has a SGF seed balance of \$24.4 M from the Oil Spill Contingency Fund. The seed was granted to cover operating expenditures relating to the Deepwater Horizon event. The Treasury seed will be repaid by DPS with funds received from the BP oil spill settlement. To the extent funds associated with settlements from the Deepwater Horizon event are directed to the Coastal Protection and Restoration Fund, DPS may not be able to repay the SGF seed.
