Mack HB No. 155

Abstract: Provides for certain law enforcement officers to receive credit for years of service for purposes of receiving supplemental compensation.

<u>Present law</u> requires every commissioned law enforcement officer employed on a full-time basis by a police agency of the state or its political subdivisions, other than DPS&C and the Dept. of Wildlife and Fisheries, who provides police services to the general public to receive supplemental compensation in the amount of \$500 per month to be paid by the state if the officer completed one year of service, was hired after March 31, 1986, and completed and passed a council-certified training program.

<u>Proposed law</u> retains <u>present law</u> and further requires any P.O.S.T.-certified law enforcement officer employed on a full-time basis by DPS&C, Dept. of Wildlife and Fisheries, division of probation and parole, or any retired state police officer who receives supplemental compensation under provisions of <u>present law</u>, to receive credit for their employment if they become employed with any other law enforcement agency for purpose of satisfying the one year of service requirement to receive supplemental compensation.
