TAX/INCOME/PERSONAL EN NO IMPACT GF RV See Note Page 1 of 1

Changes the Louisiana Chapter of the National Multiple Sclerosis Society to the National Multiple Sclerosis Society as an entity to which donations may be made on individual tax returns. (8/1/14)

Current law provides for an income tax checkoff to donate tax refunds to the Louisiana Chapter of the National Multiple Sclerosis Society, and provides an escrow fund in the state treasury with the same name.

Proposed law changes the name of the checkoff and the escrow fund to the National Multiple Sclerosis Society. Also authorizes the Senate Revenue & Fiscal Affairs committee to request reports on operations of the recipient entity. Any funds in the old fund are to be transferred into the new fund.

EXPENDITURE EXPLANATION



REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.

For information purposes, the checkoff generated over \$36,000 in donations in the two year period of FY10 and FY11 (the latest Revenue Department Annual Reports available). The Treasury reports a current balance in the fund of \$4,121, which would be transferred to the new named fund of this bill.
