27 (3)(a) Subject to appropriation by the legislature, monies in the fund shall  
28 be used solely to ~~grant incentive payments under the Louisiana Buy Local Purchase~~  
29 ~~Incentive Program as provided in this Section~~ to provide grants to eligible restaurant  
30 establishments for purchases of Louisiana agricultural products all as defined in R.S.  
31 3:284(C) and for all ordinary and necessary operating and administrative costs and  
32 expenses associated with implementation of this Section, provided that the ordinary  
33 and necessary operating and administrative costs and expenses shall not exceed five  
34 percent of monies appropriated from the fund. The Louisiana Agricultural Finance  
35 Authority shall have the authority to determine the grant recipients and the amount  
36 of the grant awards as well as other eligible expenses to be paid with monies  
37 appropriated each fiscal year.

39 F. Termination of program ~~and fund~~

1 The program ~~and fund~~ created pursuant to this Section shall terminate on  
2 December 31, 2014. Therefore, no rebate payments authorized according to the  
3 provisions of this Section shall be granted after December 31, 2014. ~~Any~~  
4 ~~unexpended and unencumbered monies in the fund at the end of the program shall~~  
5 ~~revert to the state general fund."~~

27 B. The monies in the Shreveport Riverfront and Convention Center and  
28 Independence Stadium Fund shall be subject to an annual appropriation by the  
29 legislature. The monies in the fund shall be available exclusively for the purposes  
30 provided in R.S. 47:302.2(C) and (D). However, ~~forty~~ forty-seven thousand dollars  
31 of the monies deposited in the fund shall be allocated annually to Pamoja Art Society  
32 for African-American cultural activities in Shreveport, fifty thousand dollars of the  
33 monies deposited into the fund shall be allocated annually to The Shreveport  
34 Multicultural Center, Inc., and fifteen thousand dollars of the monies deposited in the  
35 fund shall be allocated annually to the Rho Omega and Friends, Inc., for the Let the  
36 Good Times Roll Festival. All unexpended and unencumbered monies in the fund  
37 shall remain in the fund. The monies in the fund shall be invested by the treasurer in  
38 the same manner as the monies in the state general fund, and all interest earned shall  
39 be deposited in the state general fund.

19 Funds to the Mega-project Development Fund.

20 "(J) Notwithstanding any laws to the contrary, the treasurer is hereby  
21 authorized and directed to transfer the balance of the Overcollections Fund Program  
22 Participation Savings Account to the Louisiana Medical Assistance Trust Fund.

23 "(K) Notwithstanding any provision of law to the contrary, the state treasurer  
24 is authorized and directed to transfer Twenty Million Dollars from the Louisiana  
25 Mega-project Development Fund to the Rapid Response Fund.

26 "(L) The state treasurer is hereby authorized and directed to move any funds  
27 identified by the commissioner of administration from the implementation of the plan  
28 by Alvarez and Marsal to the Overcollections Fund to effectuate the preamble  
29 language contained in Act 15 of the 2014 Regular Session of the Legislature, subject  
30 to approval by the Joint Legislative Committee on the Budget."
