HOUSE CONCURRENT RESOLUTION NO. 201

HEALTH SERVICES: Requests the Department of Health and Hospitals to study the feasibility of providing Medicaid enrollees with a choice of fiscal/employer agents

1	A CONCURRENT RESOLUTION
2	To authorize and request the Department of Health and Hospitals to study the feasibility of
3	providing a choice of fiscal/employer agents, including a Louisiana-based option, to
4	Medicaid enrollees who hire a direct service worker as a home-based attendant
5	through a waiver program administered by the department.
6	WHEREAS, the office for citizens with developmental disabilities (OCDD) of the
7	Department of Health and Hospitals is charged with coordinating statewide services in a
8	manner that is accessible to Louisiana individuals and families who require specialized
9	supports and services; and
10	WHEREAS, OCDD is entrusted to ensure that individuals are afforded the
11	opportunity to live in a safe environment while directing their lives based on their desired
12	personal outcomes; and
13	WHEREAS, through the efforts of OCDD, supports and services are provided as a
14	supplement to natural supports while promoting dignity, quality of life, and security in the
15	everyday lives of people; and
16	WHEREAS, OCDD offers community-Based services and supports for persons with
17	disabilities through the Medicaid Home and Community-based Waiver programs; and
18	WHEREAS, these waiver programs allow Louisiana citizens to have greater
19	flexibility to choose where they want to live, and the waiver services and supports that best
20	suit their needs, while still receiving Medicaid State Plan benefits; and

1	WHEREAS, the office of aging and adult services of the Department of Health and
2	Hospitals administers home- and community-based long-term care services through various
3	waiver and state plan programs for individuals who are elderly or have disabilities, assisting
4	them in their homes and in the community; and
5	WHEREAS, a direct service worker is a person who assists an individual to lead a
6	self-directed life and encourages attitudes and behaviors that contribute to the community;
7	and
8	WHEREAS, the self-directed service option available through the department's
9	waiver programs allows a Medicaid enrollee to choose a direct service worker to provide
10	necessary services and supports, which maximizes the participant's choice and control over
11	services and supports; and
12	WHEREAS, a fiscal/employer agent provides financial management services for
13	self-directing participants who act as their own employer by assisting with employer payroll
14	responsibilities, without taking away the right of the participant to exercise self-direction;
15	and
16	WHEREAS, a Medicaid enrollee does not currently have the option to choose a
17	fiscal/employer agent when the enrollee hires a direct service worker; and
18	WHEREAS, it is important that a Medicaid enrollee feel assured that the
19	fiscal/employer agent will provide quality, person-centered services that promote
20	accountability and the use of cost-effective resources to address the personal needs of the
21	enrollee; and
22	WHEREAS, allowing a Medicaid enrollee to choose a Louisiana-based
23	fiscal/employer agent will help stimulate economic growth by providing employment
24	opportunities within the local community in which the business is established and will
25	provide a local contact to assist the enrollee with questions and concerns; and
26	WHEREAS, in a world of rapidly changing health care delivery and financing
27	systems, it should be the continuing goal of the Department of Health and Hospitals to
28	develop a system that meets the needs of the participants, and ensures quality and value for
29	Louisiana citizens who choose to receive services in their community.

1 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 2 authorize and request the Department of Health and Hospitals to study the feasibility of 3 providing a choice of fiscal/employer agents, including a Louisiana-based option, to 4 Medicaid enrollees who hire a direct service worker as a home-based attendant through a 5 waiver program administered by the department. 6 BE IT FURTHER RESOLVED that the department shall submit a written report of 7 its findings and conclusions, including any recommendations for legislation relative to the 8 issue, to the legislature not later than sixty days prior to the beginning of the 2015 Regular 9 Session of the Legislature of Louisiana. 10 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the

11 secretary of the Department of Health and Hospitals.
