SCHOOLS/HIGH SCHOOL EN INCREASE GF EX See Note Page 1 of 1  
Provides for State Seal of Biliteracy to recognize high school graduates who meet certain academic eligibility criteria relative to language proficiency

The proposed legislation provides for a State Seal of Biliteracy to be affixed to a high school diploma or transcript of a high school graduate who meets certain academic requirements relative to foreign language proficiency. The bill defines the academic criteria the student must meet in order to earn the seal. The bill requires the state superintendent of education to prepare and deliver an appropriate insignia to affix to the diploma or transcript and encourages but does not require public school governing authorities to participate in the program.
