2	To enact Chapter 21-A of Title 33 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 33:7631 through 7634, relative to the creation of the Cooperative
4	Local Government Infrastructure Act; to provide for the authority to enter into
5	certain cooperative endeavor agreements between the private sector and political
6	subdivisions or political corporations; to provide for local tax rebates, tax credits, or
7	other incentives; to provide for limitations; to provide for definitions; to provide for
8	an effective date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 21-A of Title 33 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 33:7631 through 7634, is hereby enacted to read as follows:
12	CHAPTER 21-A. COOPERATIVE LOCAL GOVERNMENT
13	INFRASTRUCTURE LAW
14	§7631. Short title
15	This Chapter shall be known and may be cited as the "Cooperative Local
16	Government Infrastructure Act''.
17	§7632. Declaration of purpose; applicability
18	A. The legislature hereby finds and declares that the health, safety, and
19	welfare of the people of this state are dependent upon the continued
20	encouragement, development, growth, and expansion of private sector economic
21	development within the state. The legislature further finds and declares that
22	there are certain depressed areas in the state that need the particular attention
23	of government. These depressed areas often have declining or minimal tax
24	revenues creating a widening gap in funding between the costs of public project
25	needs and available resources at the local level to address them. Finally,

investment in public infrastructure could dramatically improve the quality of

1	life of residents and make the areas more attractive to private sector economic
2	development. Therefore, it is declared to be the purpose of this Chapter to
3	stimulate a partnership between government and the private sector for business
4	growth in these depressed areas through local incentives for private sector
5	donations for local public infrastructure projects.
6	B. This Chapter shall apply only to cooperative endeavor agreements
7	which expressly cite this Chapter as authority for the agreement, and shall not
8	be construed as being applicable or otherwise limit a local government entity to
9	enter into cooperative endeavor agreements generally.
10	§7633. Cooperative endeavor agreements
11	A.(1) As authorized by Article VII, Section 14(C) of the Louisiana
12	Constitution, political subdivisions and political corporations may enter into a
13	cooperative endeavor agreement with any public or private association,
14	corporation, or individual to carry out a local infrastructure project to achieve
15	a public purpose. Any capital improvements shall be on public property and
16	for local infrastructure projects as authorized in this Chapter.
17	(2) As used in this Chapter, a "local governmental entity" shall mean the
18	political subdivision or political corporation authorized to execute a cooperative
19	endeavor agreement under this Chapter.
20	B. This cooperative endeavor agreement may provide for the investment,
21	pledge, use, or deposit of private funds and the guarantee by the public or
22	private association, corporation, or individual of certain financial obligations,
23	to achieve the goals set forth in the agreement. The agreement shall state how
24	the donation for the project will result in the furtherance of a public purpose of
25	the local government entity.
26	C. The cooperative endeavor agreement shall set forth in reasonable
27	detail the following items:
28	(1) The obligations of the various parties.
29	(2) A showing of reasonable expectations that the benefits to be received
30	by the local governmental entity from the donation equal or exceed any local tax

1	rebates, tax credits, or other incentives to be awarded on the project.
2	(3) Consequences to the public or private association, corporation, or
3	individual in the event of a default or breach of the agreement by the
4	association, corporation, or individual that shall include a repayment to the
5	local governmental entity when appropriate, of any rebates, tax credits, or other
6	incentives awarded or expenses incurred.
7	§7634. Tax rebates, tax credits, or other incentives for donations
8	A. Tax rebates, tax credits, or other incentives shall be allowed for
9	qualified donations made to a local governmental entity for a qualified project
10	subject to the following limitations:
11	(1) A participating donor shall submit to the chief financial officer
12	designated by the local governmental entity a written report reasonably
13	documenting the cash, equipment, goods, or services donated pursuant to a
14	cooperative endeavor agreement for a qualified project, including supporting
15	documentation as may be deemed necessary by that officer. Prior to the
16	approval of tax rebates, tax credits, or other incentives for a qualified donation
17	under the cooperative endeavor agreement, the officer shall verify the value of
18	the qualified donation.
19	(2) The local governmental entity may approve a tax rebate, tax credit,
20	or other incentive to the donor for the verified qualified donation in an amount
21	equal to one-half of the value of the cash, equipment, goods, or services donated,
22	or five hundred thousand dollars, whichever is less. The total amount of the tax
23	rebates, tax credits, or other incentives which may be received by any donor in
24	any fiscal year shall not exceed five hundred thousand dollars.
25	B.(1) The term "qualified donation" shall mean a donation made to a
26	participating local governmental entity to assist in the construction, operation,
27	use, or maintenance of a qualified project. The donation may be in the form of
28	cash or the donation of equipment, goods, or services.
29	(2) The term "qualified project" shall mean a project for the

construction or major improvement or repair of infrastructure by a

1 participating local governmental entity. 2 C. The local governmental entity shall promulgate such rules and 3 regulations as may be deemed necessary to carry out the purposes of this 4 Chapter. 5 D. The provisions of this Chapter shall apply to verified qualified donations made after July 1, 2014. 6 7 Section 2. This Act shall become effective upon signature by the governor or, if not 8 signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 9 10 vetoed by the governor and subsequently approved by the legislature, this Act shall become 11 effective on the day following such approval.
