Provides relative to criminal history of an adult living in a foster home

Present law (R.S. 46:51.2(C)) prohibits a child from being placed in a foster home for temporary care if an adult living in the home has been convicted of certain drug related crimes - a Schedule I, II, III, IV, or V controlled dangerous substance. Proposed law retains present law but allows consideration of a prospective foster or adoptive parent who has not been convicted or pled nolo contendere to a felony drug offense within the past 5 years. Proposed law provides the the Department of Children and Family Services (DCFS) must determine that the prospective foster or adoptive parent has not been convicted of or pled nolo contendere to a felony drug offense within 5 years between the date of placement and the date of successful completion of any sentence, deferred adjudication, or period of probation or parole. Proposed law provides that the prospective foster or adoptive parent submit to and pass an initial drug test as well as consent to future drug testing by DCFS for the duration of the child's placement. Proposed law provides the prospective foster or adoptive parent pay for the drug testing.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The proposed legislation allows the Department of Children and Family Services (DCFS) to consider an adult as a prospective foster or adoptive parent if that individual has not been convicted or pled nolo contendere to a felony drug offense within the past 5 years. Presently, these individuals are automatically ineligible from consideration as a prospective foster or adoptive parent. Also, before a child is placed with prospective foster or adoptive parent with a felony drug offense, the individual must have passed an initial drug test and consent to random drug testing by DCFS for the duration of the placement. Since this measure requires all drug testing shall be paid for by the prospective foster or adoptive parent, there is not impact on DCFS expenditures.
