Proposed law provides that a justice of the peace may perform a marriage ceremony in any parish which has no justice of the peace so long as the two parishes are within the same supreme court district with the exception of Orleans Parish. Proposed law also requires for a 30 day appointment of an ad hoc justice of the peace and further provides that a justice of the peace making such ad hoc appointment must notify and provide all contact information to the office of the attorney general within 72 hours of installing a new ad hoc justice of the peace in his territorial court boundaries.
