2	To amend and reenact R.S. 37:1031(A) and 1033(A)(introductory paragraph), relative to
3	care for individuals receiving certain home- and community-based services; to
4	provide for applicability of laws relative to services rendered by direct service
5	workers; to revise criteria for individuals who are served by direct service workers;
6	to provide for requirements relative to authorization for direct service workers to
7	perform certain procedures; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 37:1031(A) and 1033(A)(introductory paragraph) are hereby
10	amended and reenacted to read as follows:
11	§1031. Applicability
12	A. The provisions of this Part shall not apply to gratuitous care provided by
13	friends or members of the individual's family. The provisions of this Part shall apply
14	to all direct service workers employed by a licensed agency, or employed as part of
15	an authorized departmental self-directed program, and who attend to individuals
16	receiving home- and community-based long-term services and who are not
17	authorized to perform these tasks under other state laws or regulations. An
18	individual being served shall meet the following criteria:
19	(1) Is eligible for home- and community-based long-term care services
20	licensed by the Department of Health and Hospitals.
21	(2) Is able to self-direct the services or resides Resides in a residence where
22	there is daily monitoring by a family member, a direct service worker, or other health
23	care provider.
24	(3) Has a current plan of care.

If the direct 13 service worker is employed by a licensed agency he shall receive the following 14 training: 15 16 Section 2.(A) The legislature hereby finds that personal care and other services and 17 supports provided to persons with disabilities in home- and community-based settings can 18 be of immense value in enhancing those persons' well-being and quality of life. 19 (B) This Act shall be known as "Bailey's Law" in recognition of the advocacy efforts 20 on behalf of persons with disabilities that have been inspired by Bailey Caroline Durham.
