2	To amend and reenact R.S. 17:500.2(A)(2)(c), 1202(A) and (E)(1)(a), and 1206.2(A)(2)(c),
3	to enact R.S. 17:500.2(A)(2)(d) and 1206.2(A)(2)(d), and to repeal R.S.
4	17:500.2(E)(1)(b), 1202(E)(1)(b), and 1206.2(E)(1)(b), relative to extended sick
5	leave for employees of school boards; to provide for additional such leave for
6	teachers for certain purposes; to provide definitions; to provide relative to
7	requirements for extension of such leave; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 17:500.2(A)(2)(c), 1202(A) and (E)(1)(a), and 1206.2(A)(2)(c) are
10	hereby amended and reenacted and R.S. 17:500.2(A)(2)(d) and 1206.2(A)(2)(d) are hereby
11	enacted to read as follows:

18	(c) <u>"Medical necessity" means the result of catastrophic illness or injury, a</u>
19	life threatening condition, a chronic condition, or an incapacitating condition, as
20	certified by a physician, of a school bus driver or an immediate family member.
21	(d) "Parent" means the biological parent of a school bus operator or an
22	individual who stood in loco parentis to the school bus operator.

1	§1202. Teachers; extended sick leave
2	A.(1) Every city, parish, and other local public school board shall permit:
3	(a) Each teacher to take up to ninety days of extended sick leave in each six-
4	year period of employment, which may be used for a medical necessity in the
5	manner provided in this Section at any time that the teacher has no remaining regular
6	sick leave balance.
7	(b) Each teacher granted maternity leave in accordance with the provisions
8	of R.S. 17:48 or 1211 and who has no remaining sick leave balance available to take
9	in the manner provided in this Section up to thirty days of additional extended sick
10	leave in each six-year period of employment for personal illness relating to
11	pregnancy, illness of an infant, or for required medical visits certified by a physician
12	as relating to infant or maternal health related to the purpose for which the maternity
13	leave was granted.
14	(2) As used in this Section the following terms shall have the following
15	meanings:
16	(a) "Child" means a biological son or daughter, an adopted son or daughter,
17	a foster son or daughter, a stepson or daughter, or a legal ward of a teacher standing
18	in loco parentis to that ward who is either under the age of eighteen, or who is
19	eighteen years of age but under twenty-four years of age and is a full-time student,
20	or who is nineteen years of age or older and incapable of self-care because of a
21	mental or physical disability.
22	(b) "Immediate family member" means a spouse, parent, or child of a
23	teacher.
24	(c) <u>"Infant" means a child under one year of age.</u>
25	(d) "Medical necessity" means the result of catastrophic illness or injury, a
26	life threatening condition, a chronic condition, or an incapacitating condition, as
27	certified by a physician, of a teacher or an immediate family member.
28	(e) "Parent" means the biological parent of a teacher or an individual who
29	stood in loco parentis to the teacher.

1	E.(1)(a) On every occasion that a teacher uses extended sick leave, a
2	statement from a licensed physician certifying that it is for personal illness relating
3	to pregnancy, illness of an infant, or for required medical visits related to infant or
4	maternal health related to the purpose for which maternity leave was granted or that
5	it is a medical necessity for the teacher to be absent for ten consecutive work days
6	shall be presented prior to the extension of such leave.
