SUCCESSIONS EN NO IMPACT See Note Page 1 of 1  
Provides relative to electronic assets of a decedent. (8/1/14)

This law provides that a succession representative shall have the power to control any digital media of the decedent except for any restrictions provided in a valid testament of a decedent or by order of the court of competent jurisdiction. Further, the authority provided by proposed law will only extend to copyright law and not serve to extend the scope of the license granted for any digital media account. Digital media includes social media pages, web blogs, e-mail accounts, financial accounts, or any other similar electronic services. Transfer of federally insured financial accounts must still meet the standards as provided in R.S. 6:325 and 6:767. Control of the digital accounts will be delivered to the succession representative within 30 days of receiving a death certificate of the decedent.
