2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2015-3 2016 to be used to pay the consent judgment in the suit entitled "Donald M. Ragusa, 4 Individually and on behalf of his minor son, Trevor Ragusa, and Tina Cristina v. 5 State of Louisiana, through the Department of Transportation and Development"; 6 and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. The sum of One Hundred Seventy-Five Thousand and No/100 (\$175,000) 9 Dollars, in favor of Donald M. Ragusa and the sum of One Hundred Seventy-Five Thousand 10 and No/100 (\$175,000) Dollars in favor of Tina Cristina is hereby appropriated out of the 11 General Fund of the state of Louisiana for Fiscal Year 2015-2016 to be used to pay the 12 consent judgment in the suit entitled "Donald M. Ragusa, Individually and on behalf of his 13 minor son, Trevor Ragusa, and Tina Cristina v. State of Louisiana, through the Department 14 of Transportation and Development", bearing Number 582,173 on the docket of the 19th 15 Judicial District Court, parish of East Baton Rouge, state of Louisiana. 16 Section 2. This Act shall become effective on July 1, 2015; if vetoed by the governor 17 and subsequently approved by the legislature, this Act shall become effective on July 1, 18 2015, or on the day following such approval by the legislature, whichever is later.
