Purpose of Bill: This measure would allow the Clerks of Court in East and West Feliciana Parishes to to charge an additional \$10 fee for the issuance of certified copies of birth and death certificates.

EXPENDITURE EXPLANATION

Although this bill does not directly provide for expenditures, Clerk of Court officials informed us that there may be an increase in local government expenditures by up to \$86,500.

The Clerk of Court for West Feliciana Parish foresees the need to hire one new full-time employee to help handle the increase in requests for birth/death certificates. The estimated cost for the new employee is \$37,930 per year. (Salary, insurance, and retirement)

The Clerk of Court for East Feliciana Parish foresees the need to hire one new full-time and one part-time employe to help handle the increase in requests for birth/death certificates. The estimated cost for these two new employees is \$48,562 per year. (Salary, insurance, and retirement for full-time; and salary only for part-time)

REVENUE EXPLANATION

This bill may increase local government revenues by up to approximately \$67,700 per year.

The Clerk of Court in West Feliciana Parish estimates that as a result of this bill, her office would receive an additional \$20,370 a year. (2,037 certificates issued X \$10).

The Clerk of Court in East Feliciana Parish estimates that as a result of this bill, his office would receive an additional \$47,340 a year. (4,734 certificates issued X \$10 additional fee)
