 R.S. 24:513, and upon two-thirds vote of the entire membership of the council, may
 forward its determination of noncompliance to the Joint Legislative Committee on
- 21 the Budget.
- 22 (ii) If the Joint Legislative Committee on the Budget receives a
 23 determination of noncompliance pursuant to Item (i) of this Subparagraph, the
 24 committee shall hold a hearing on the matter. If the committee determines that the
 25 auditee has failed for three consecutive years to sufficiently resolve the findings
 26 contained in an audit report of such auditee, the committee may, by the adoption of
 27 a committee resolution, provide for the imposition of a penalty upon the auditee by
 28 recommendation to the legislature that provisions for such penalty be included in a
- subsequent appropriation for the auditee.
- 30 (iii) The provisions of Items (i) and (ii) of this Subparagraph shall apply only
 31 to financial findings, findings relative to a material weakness as defined by the
- Governmental Accounting Standards Board, or findings in a compliance audit."
