23 thousand dollars in the department's annual report. Any taxpayer who accepts the
24 remittance or waiver of penalties shall be deemed to have consented to the
25 publication of the complete record of the remittance or waiver of penalty in the
26 department's annual report. This provision shall not apply to any penalty the
27 secretary remits or waives in accordance with rules and regulations promulgated
28 pursuant to the Administrative Procedure Act regarding the remittance or waiver of
29 penalties under the department's voluntary disclosure program.
