 Changes the description of a capital improvement project for the SOWELA Technical Community College to be financed through the sale of bonds

Proposed law increases the Workforce and Technical Education project allocation by \$3.6M for the Capital Area Technical College Welding Center (from \$3.33M to \$6.93M). The bill also eliminates \$3.6M in Safety, Security, and Infrastructure funding for a secure parking garage at the Capital Area Technical College Campus. Finally, the bill changes the project referenced for the SOWELA Technical Community College from an Automotive, Welding, Nursing, and Industrial Programs building on the Morgan Smith Campus to a project on the main campus. Effective July 1, 2015.
