20	Delegation, the Louisiana Republican Legislative Delegation, and the Louisiana Rural
21	Caucus; and

23	tremendously from the leadership of Speaker Kleckley; and
24	WHEREAS, Speaker Kleckley has proven to be a vital asset to the state of Louisiana,
