AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2016-3 2017 to be used to pay the consent judgment in the suit entitled "Billy Wallace v. 4 Eric M. Hill, Unitran Auto & Home Insurance Company, Ideallease of Acadiana, 5 LLC, Daniel J. Guidry, Sentry Insurance a Mutual Company, State of Louisiana, via 6 the Louisiana Department of Transportation and Development"; and to provide for 7 related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. The sum of Sixty-Three Thousand Eight Hundred Fifty-Eight and No/100 10 (\$63,858.00) Dollars is hereby appropriated out of the General Fund of the state of Louisiana 11 for Fiscal Year 2016-2017 to be used to pay the consent judgment in the suit entitled "Billy 12 Wallace v. Eric M. Hill, Unitran Auto & Home Insurance Company, Ideallease of Acadiana, 13 LLC, Daniel J. Guidry, Sentry Insurance a Mutual Company, State of Louisiana, via the 14 Louisiana Department of Transportation and Development", bearing Number 2008-2677 "F" 15 on the docket of the Fourteenth Judicial District Court, parish of Calcasieu, state of 16 Louisiana. 17 Section 2. This Act shall become effective on July 1, 2016; if vetoed by the governor 18 and subsequently approved by the legislature, this Act shall become effective on July 1, 19 2016, or on the day following such approval by the legislature, whichever is later.
