22 their entirety.23 Section 3. The provisions of this Act shall not affect any existing incentive or credit
24 program contracts that were entered into before July 1, 2017; however no new contracts shall
25 be entered into after June 30, 2017. All unused credits earned before July 1, 2017, may be
26 used beyond July 1, 2017, on the same basis and to the same extent as permitted under the
27 provisions of law as they existed immediately prior to July 1, 2017.28 Section 4. The provisions of this Section and Sections 2 and 3 of this Act shall
29 become effective July 1, 2017.30 Section 5. The provisions of this Section and Section 1 of this Act shall become
31 effective upon signature by the governor or, if not signed by the governor, upon expiration
32 of the time for bills to become law without signature by the governor, as provided by Article
33 III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently
34 approved by the legislature, this Act shall become effective on the day following such
35 approval."
