Constitutional amendment to revise the circumstances that would allow the reduction of constitutionally protected expenditures and dedications to eliminate a projected deficit in an ensuing fiscal year. (2/3 - CA13s1(A)) The proposed constitutional amendment authorizes the use of constitutional and dedicated funds to eliminate a projected

deficit if the Legislative Fiscal Office (LFO) reports that the state budget estimate provides for appropriations out of the SGF and dedicated funds for the ensuing fiscal year for either healthcare of higher education in an amount less than the allocation contained in the existing operating budget (EOB) for the current fiscal year.

## **EXPENDITURE EXPLANATION**

Pursuant to R.S. 24:603(20), the LFO currently prepares and submits a similar report (Act 424 of 2013) to the governor and the legislature within 7 days of the submittal of the Executive Budget to the Joint Legislative Committee on the Budget. Act 424 identifies healthcare as contained in Schedule 09 (Department of Health & Hospitals) and higher education as contained in Schedule 19 (Higher Education and LSU Health Sciences Center Health Care Services Division). The LFO assumes that healthcare and higher education expenditures, as referenced in this bill, are defined the same as in Act 424.

It should be noted that the threshold (a lower apppropriation for healthcare and highter education) for triggering the constitutional budget balancing measures in this bill is lower than under the current law (a 1% drop in revenue forecast), which will allow for the redistribution of statutory dedications for purposes other than provided by law.

The Department of State budgets for up to 10 constitutional amendments for the fall statewide elections as regular practice and any costs associated with this proposed constitutional amendment will be absorbed within the agency's budget.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
