Amendments proposed by House Committee on Appropriations to Original House Bill No. 812 by Representative Schroder

1 AMENDMENT NO. 1

2 On page 1, at the end of line 2, insert "or leased"

3 AMENDMENT NO. 24 On page 1, line 11, after "owned" insert "or leased"5 AMENDMENT NO. 36 On page 1, at the end of line 13, insert "or leased"7 AMENDMENT NO. 4

8 On page 1 between lines 14 and 15, insert the following:

9 "B. Each agency that occupies space greater than ten thousand square feet  
10 shall submit to the division of administration by July first of each year and updated  
11 by January first of each year, the identity of any and all office space in state-owned  
12 or leased buildings by location and square footage and the identity of any unoccupied  
13 or underutilized office space in state-owned or leased buildings by location and  
14 square footage."

15 AMENDMENT NO. 516 On page 1, at the beginning of line 15, change "B." to "C."17 AMENDMENT NO. 618 On page 1, line 17, after "updated" change "monthly," to "semi-annually,"19 AMENDMENT NO. 720 On page 1, delete line 18 and insert "or leased buildings by location and square footage."21 AMENDMENT NO. 8

22 Delete page 2 in its entirety and insert the following:

23 "(2) Identify all available office space that the division of administration  
24 determines is suitable for the needs of an agency with leased space, and within thirty  
25 days after the semi-annual update of the list required in this Section, send a notice  
26 to the head of such agency of such available space.

27 D. Within ninety days of the notification provided in this Section, the agency  
28 head shall respond to the notice with a transitional plan for moving into the available  
29 space or a detailed indication of why the space is not suitable for use by the agency.

30 E. If the agency does not submit a transitional plan for moving into the space  
31 identified or does not move in the time indicated in the plan, the notice to the agency  
32 and the agency's response required by this Section shall be included in a report by

1 the division of administration to the Joint Legislative Committee on the Budget on  
2 or before March first of each year."

3 AMENDMENT NO. 9

4 On page 3, at the beginning of line 1, change "D." to "F."

5 AMENDMENT NO. 10

6 On page 3, between lines 6 and 7, insert the following:

7 "G. The division of administration shall comply with federal laws and  
8 regulations and with state-federal agreements with respect to the housing of any  
9 agency, or its personnel, operations, equipment, or activities, which receives or  
10 administers any federal funds."

11 AMENDMENT NO. 11

12 On page 3, at the beginning of line 7, change "E." to "H."

13 AMENDMENT NO. 12

14 On page 3, line 9, after "R.S." change "27:127(C)" to "39:127(C)"

16 AMENDMENT NO. 13

17 On page 3, between lines 11 and 12, insert the following:

18 "(3) "Lease" means any agreement, including but not limited to cooperative  
19 endeavor agreements, professional services contracts, and consulting services  
20 contracts which gives rise to relationships of landlord and tenant or lessor and  
21 lessee."

23 On page 3, at the beginning of line 12, change "(3)" to "(4)"

24 AMENDMENT NO. 15

25 On page 3, at the beginning of line 15, change "(4)" to "(5)"

26 AMENDMENT NO. 16

27 On page 3, line 15, after "owned" insert "or leased"

28 AMENDMENT NO. 17

29 On page 3, line 15, after "public building" insert a comma "," and "or a portion of a  
30 building."
