HOUSE CONCURRENT RESOLUTION NO. 9

HUNTING: Creates the Feral Hog Management Advisory Task Force

1 A CONCURRENT RESOLUTION

2 To create the Feral Hog Management Advisory Task Force in the Department of Wildlife  
3 and Fisheries.

4 WHEREAS, feral hogs (*Sus scrofa*), including European wild hogs and hybrids,  
5 commonly weigh two hundred pounds but can easily weigh up to four hundred pounds, are  
6 quickly becoming the most serious problem facing land managers and hunters in Louisiana;  
7 and

8 WHEREAS, feral hogs are omnivorous but vegetation constitutes the largest portion  
9 of their diet as they use their very tough nose that allows them to “root” for invertebrates,  
10 tubers, or any other underground food, thereby disrupting crops, golf courses, levees,  
11 hayfields, tree farms, and even lawns; and

12 WHEREAS, feral hogs are extremely prolific with generally two litters per year of  
13 up to ten piglets per litter; while the feral hogs have virtually no natural predators, so piglet  
14 survival is nearly one hundred percent which allows the population to increase  
15 geometrically; and

16 WHEREAS, feral hogs are plagued by a multitude of diseases that can affect humans,  
17 commercial swine operations, or wildlife, including swine brucellosis, pseudorabies, and  
18 classical swine fever; and

1           WHEREAS, with their high proliferation and lack of natural predators, management  
2 of feral hogs is of paramount importance to the state and the hunters and farmers of the state.

3           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
4 create the Feral Hog Management Advisory Task Force in the Department of Wildlife and  
5 Fisheries as follows:

6           A. There is hereby established the Feral Hog Management Advisory Task  
7 Force to study and monitor the feral hog issues in the state of Louisiana and to make  
8 recommendations for the management of the feral hogs.

9           B. The task force shall be composed as follows:

10           (1) One member appointed from the staff of the Department of Wildlife and  
11 Fisheries by the secretary of the Department of Wildlife and Fisheries.

12           (2) One member appointed from the staff of the Department of Agriculture  
13 and Forestry by the commissioner of agriculture.

14           (3) One member appointed by the secretary of the Department of Wildlife  
15 and Fisheries from three nominees submitted by the Louisiana Hog Hunters  
16 Association.

17           (4) One member appointed by the secretary of the Department of Wildlife  
18 and Fisheries from three nominees submitted by the Louisiana Landowners  
19 Association.

20           (5) One member appointed by the commissioner of agriculture from three  
21 nominees submitted by the Louisiana Forestry Association.

22           (6) One member appointed by the secretary of the Department of Wildlife  
23 and Fisheries from three nominees submitted by the Louisiana Quality Deer  
24 Management Association.

25           (7) One member who is a landowner in the state of Louisiana appointed by  
26 the secretary of the Department of Wildlife and Fisheries.

27           (8) One member who is a resident of Louisiana and a licensed deer hunter  
28 in the state of Louisiana appointed by the secretary of the Department of Wildlife  
29 and Fisheries.

1           (9) One member appointed by the commissioner of agriculture from three  
2 nominees submitted by the Louisiana Farm Bureau Federation.

3           (10) One member appointed from the staff of the Coastal Protection and  
4 Restoration Authority by the Governor's executive assistant on coastal activities.

5           (11) One member appointed by the secretary of the Department of Wildlife  
6 and Fisheries from three nominees submitted by the Association of Levee Boards of  
7 Louisiana.

8           C. The members appointed under the provisions of Paragraphs (B)(1), (2),  
9 and (10) of this Section shall be nonvoting members. However, they shall be  
10 considered members of the task force for determination of the number of members  
11 necessary for a quorum and for establishing the presence of a quorum.

12           D. Six members of the task force shall constitute a quorum sufficient to  
13 conduct meetings and business of the task force. The task force shall elect a  
14 chairman from its membership and may seek and receive assistance from universities  
15 within the state in the development of methods to manage feral hogs in the state of  
16 Louisiana. The members of the task force shall serve without compensation;  
17 however, the task force may receive the same reimbursement of travel expenses for  
18 attending task force meetings as is allowed for other state employees' travel.

19           E. The task force is hereby charged with the responsibility to make  
20 recommendations with respect to issues pertaining to feral hog management efforts,  
21 including public awareness programs, to the various state agencies charged with the  
22 responsibility for managing the feral hogs in this state, including the Department of  
23 Wildlife and Fisheries, the Department of Agriculture and Forestry, and the  
24 legislature. The task force shall consider hunter-based solutions and shall gather  
25 input from various stakeholder groups.

26           F. The Feral Hog Management Advisory Task Force shall submit an annual  
27 report to the House Committee on Natural Resources and Environment and the  
28 Senate Committee on Natural Resources no later than February 1<sup>st</sup> of each year and  
29 shall cease to exist on January 1, 2020, and thereafter.

1 BE IT FURTHER RESOLVED that the Department of Wildlife and Fisheries, from  
2 the monies appropriated to the department by the legislature, is hereby directed to fund  
3 activities related to feral hog management, education, research, and control during Fiscal  
4 Year 2016-2017 in an amount not less than Three Hundred Sixty Thousand Dollars in excess  
5 of the amount expended for such purpose during Fiscal Year 2015-2016.

6 BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the  
7 secretary of the Department of Wildlife and Fisheries and the commissioner of agriculture.

Creates the Feral Hog Management Advisory Task Force composed as follows:

- (1) One member appointed from the staff of the Dept. of Wildlife and Fisheries by the secretary of the Dept. of Wildlife and Fisheries.
- (2) One member appointed from the staff of the Dept. of Agriculture and Forestry by the commissioner of agriculture.
- (3) One member appointed by the secretary of the Dept. of Wildlife and Fisheries from three nominations submitted by the La. Hog Hunters Association.
- (4) One member appointed by the secretary of the Dept. of Wildlife and Fisheries from three nominations submitted by the La. Landowners Association.
- (5) One member appointed by the commissioner of agriculture from three nominations submitted by the La. Forestry Association.
- (6) One member appointed by the secretary of the Dept. of Wildlife and Fisheries from three nominations submitted by the La. Quality Deer Management Association.
- (7) One member appointed by the secretary of the Dept. of Wildlife and Fisheries who is a landowner in the state of La.
- (8) One member appointed by the secretary of the Dept. of Wildlife and Fisheries who is a resident of La. and a licensed deer hunter in the state of La.
- (9) One member appointed by the commissioner of agriculture from three nominations submitted by the La. Farm Bureau Federation.
- (10) One member appointed by the governor's executive assistant on coastal activities from the staff of the Coastal Protection and Restoration Authority.
- (11) One member appointed by the secretary of the Dept. of Wildlife and Fisheries from three nominations submitted by the Association of Levee Boards of La.

Provides that the members of the task force serve without compensation; however, authorizes them to receive the same reimbursement of travel expenses for attending the meetings as is allowed for other state employees' travel.

Provides that the task force is hereby charged with the responsibility to make recommendations with respect to issues pertaining to feral hog management efforts, including public awareness programs, to the various state agencies charged with responsibility for managing the feral hogs in this state, including the Dept. of Wildlife and Fisheries, the Dept. of Agriculture and Forestry, and the legislature. Requires the task force to consider hunter-based solutions based on input from stakeholder groups.

Requires the task force to submit an annual report by Feb. 1<sup>st</sup> of each year and sunsets the task force on Jan. 1, 2020.

Directs the Dept. of Wildlife and Fisheries, from monies appropriated to the department, to provide an additional \$360,000 to fund activities related to feral hog management, education, research, and control during FY 2016 over and above the amount expended during FY 2015.

#### Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Natural Resources and Environment to the original bill:

1. Provide that the commissioner of agriculture appoint the member nominated by the La. Forestry Association.
2. Add members as follows:

One member appointed by the commissioner of agriculture from three nominations submitted by the La. Farm Bureau Federation.

One member appointed by the governor's executive assistant on coastal activities from the staff of the Coastal Protection and Restoration Authority.

One member appointed by the secretary of the Dept. of Wildlife and Fisheries from three nominations submitted by the Association of Levee Boards of La.
3. Adjust the quorum to reflect a majority of the commission members.
4. Remove the provision specifying funding the task force from the Feral Hog Management Account.
5. Require the task force to submit an annual report by Feb. 1<sup>st</sup> of each year.
6. Sunset the task force on Jan. 1, 2020.
7. Direct the Dept. of Wildlife and Fisheries, from monies appropriated to the department, to provide an additional \$360,000 to fund activities related to feral hog management, education, research, and control during FY 2016 over and above the amount expended during FY 2015.
