CRIME/PUNISHMENT. Adds Medicaid fraud to crimes governed by racketeering laws. (gov sig)

1	AN ACT
2	To amend and reenact R.S. 14:70.1(B) and to enact R.S. 15:1352(A)(63), relative to
3	racketeering; to add Medicaid fraud to the list of crimes governed by state
4	racketeering laws; to provide penalties; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 14:70.1(B) is hereby amended and reenacted to read as follows:
7	§70.1. Medicaid fraud
8	* * *
9	B.(1) Whoever Except as provided in Paragraph (2) of this Subsection,
10	whoever commits the crime of Medicaid fraud shall be imprisoned, with or without
11	hard labor, for not more than five years, or may be fined not more than twenty
12	thousand dollars, or both.
13	(2) Whoever commits the crime of Medicaid fraud involving
14	racketeering activity as defined in R.S. 15:1352(A)(63) when the amount of the
15	violation exceeds one hundred thousand dollars shall be imprisoned, with or
16	without hard labor, for not less than one nor more than ten years, at least one
17	year of which shall be served without benefit of probation, parole, or suspension

inter crea	<u>ent law</u> provides that the crime of Medicaid fraud is the act of any person who, with nt to defraud the state or any person or entity through any medical assistance program ted under the federal Social Security Act and administered by the Dept. of Health and pitals or any other state agency, does any of the following:
(1)	Presents for allowance or payment any false or fraudulent claim for furnishing services or merchandise.
(2)	Knowingly submits false information for the purpose of obtaining greater compensation than that to which he is legally entitled for furnishing services or merchandise.

(3) Knowingly submits false information for the purpose of obtaining authorization for furnishing services or merchandise.

Proposed law retains present law.

<u>Present law</u> provides that the crime of Medicaid fraud is punishable by imprisonment, with or without hard labor, for up to five years, or a fine of up to \$20,000, or both.

<u>Proposed law</u> retains <u>present law</u> and adds that Medicaid fraud involving racketeering activity as defined in <u>present law</u> when the amount of the violation exceeds \$100,000 is punishable by imprisonment, with or without hard labor, for between one and 10 years, at least one year of which must be served without benefit of probation, parole, or suspension of sentence, and in addition may be fined up to \$20,000.

<u>Present law</u> provides that "racketeering activity" means committing, attempting to commit, conspiring to commit, or soliciting, coercing, or intimidating another person to commit any crime that is punishable under certain provisions of <u>present law</u> including solicitation for murder, second degree murder, aggravated kidnapping, extortion, theft, manufacture and distribution of certain drugs, money laundering, corrupt influencing, public contract fraud, and pornography involving juveniles.

<u>Proposed law</u> retains <u>present law</u> and adds the <u>present law</u> crime of Medicaid fraud to this list.

Effective upon signature of the governor or lapse of time for gubernatorial action.
