8 (1)(a) Full rate production: ~~one and one-half cents per barrel on crude oil and~~
9 ~~condensate or~~ For crude oil and condensate, the fee shall be based on the oil price on
10 July first of each year for the ensuing twelve months based upon the average New
11 York Mercantile Exchange Price per barrel of crude oil per month on the close of
12 business on June thirtieth for the prior twelve months. The amount of the fee for a
13 well that produces crude oil and condensate shall be as follows:

14 (i) The fee shall be one and one-half cents per barrel on crude oil and
15 condensate if the price of oil is at or below sixty dollars per barrel.

16 (ii) The fee shall be three cents per barrel on crude oil and condensate if the
17 price of oil is above sixty dollars and at or below ninety dollars per barrel.

18 (iii) The fee shall be four and one-half cents per barrel on crude oil and
19 condensate if the price of oil is above ninety dollars per barrel.

20 (b) For natural gas and casing head gas, the fee shall be three-tenths of one
21 cent per thousand cubic feet ~~on natural gas and casing head gas.~~
