PRESCRIPTION. Extends period within which to file delictual actions from one to two years. (gov sig)

2	To amend and reenact Civil Code Articles 3492 and 3493, relative to liberative prescription;
3	to provide that delictual actions shall prescribe in two years; and to provide for

5	Be it enacted by the Legislature of Louisiana:
6	Section 1. Civil Code Articles 3492 and 3493 are hereby amended and reenacted to
7	read as follows:
8	CHAPTER 4. LIBERATIVE PRESCRIPTION
9	SECTION 1. ONE TWO YEAR PRESCRIPTION
10	Art. 3492. Delictual actions
11	Delictual actions are subject to a liberative prescription of one year two
12	years. This prescription commences to run from the day injury or damage is
13	sustained. It does not run against minors or interdicts in actions involving permanent
14	disability and brought pursuant to the Louisiana Products Liability Act or state law
15	governing product liability actions in effect at the time of the injury or damage.
16	Art. 3493. Damage to immovable property; commencement and accrual of
17	prescription

Page 1 of 2 Coding: Words which are struck through are deletions from existing law; words in **boldface type and underscored** are additions.

When damage is caused to immovable property, the one two year 1 prescription commences to run from the day the owner of the immovable acquired, 2 3 or should have acquired, knowledge of the damage. 4 SECTION 1-A. TWO-YEAR PRESCRIPTION \* \* \* 5 Section 2. The provisions of this Act shall have prospective application only and 6 7 shall apply only to a cause of action arising on or after the effective date of this Act. 8 Section 3. This Act shall become effective upon signature by the governor or, if not 9 signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 10 11 vetoed by the governor and subsequently approved by the legislature, this Act shall become 12 effective on the day following such approval.

Present law provides that delictual actions are subject to a liberative prescription of one year. <u>Proposed law</u> changes the time period <u>from</u> one year to two years.

Effective upon signature of the governor or lapse of time for gubernatorial action.
