**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Health and Welfare to Original House Bill  
No. 969 by Representative Cox

1 AMENDMENT NO. 1

2 On page 1, line 2, after "adults;" and before "to require" insert "to require the Department  
3 of Health and Hospitals to provide educational information on shingles and pneumonia;"

4 AMENDMENT NO. 2

5 On page 1, line 11, after "Prevention," delete the remainder of the line and delete lines 12  
6 through 16 in their entirety and insert in lieu thereof the following:

7 "the Department of Health and Hospitals shall provide to licensed nursing  
8 homes with educational information on zoster, also known as shingles. The  
9 educational information shall include, at a minimum, the risks associated  
10 with shingles and how to protect oneself against the varicella-zoster virus.  
11 The licensed nursing homes shall disseminate this information to their  
12 residents."

13 AMENDMENT NO. 3

14 On page 1, line 19, after "Prevention," delete the remainder of the line and delete line 20 in  
15 its entirety and insert in lieu thereof the following:

16 "the Department of Health and Hospitals shall provide nursing facilities with educational  
17 information on pneumonia. The educational"

18 AMENDMENT NO. 4

19 On page 2, line 1, after "pneumonia" delete the comma "," and the remainder of the line and  
20 delete lines 2 through 4 in their entirety and insert in lieu thereof the following:

21 "and the availability of the pneumococcal immunization. The licensed nursing homes shall  
22 disseminate this information to their residents."

23 AMENDMENT NO. 5

24 On page 2, line 12, after "Prevention," delete the remainder of the line and delete lines 13  
25 through 17 in their entirety and insert in lieu thereof the following:

26 "the Department of Health and Hospitals shall provide to licensed adult  
27 residential care providers with educational information on zoster, also known  
28 as shingles. The educational information shall include, at a minimum, the  
29 risks associated with shingles and how to protect oneself against the  
30 varicella-zoster virus. The licensed adult residential care providers shall  
31 disseminate this information to their residents."

32 AMENDMENT NO. 6

33 On page 2, line 20, after "Prevention," delete the remainder of the line and delete line 21 in  
34 its entirety and insert in lieu thereof the following:

35 "the Department of Health and Hospitals shall provide licensed adult residential care  
36 providers with educational information on pneumonia. The"

2 On page 2, line 23, after "pneumonia" delete the comma "," and the remainder of the line and  
3 delete lines 24 and 25 in their entirety and insert in lieu thereof the following:

4 "and the availability of the pneumococcal immunization. The licensed adult residential care  
5 providers shall disseminate this information to their residents."
