1 AMENDMENT NO. 1

2 On page 1, line 2, delete "enact R.S. 36:254(A)(15) and 474(A)(13)," and insert in lieu
3 thereof "amend and reenact R.S. 17:7(22) and to enact R.S. 17:7(33) and R.S.
4 36:254(A)(15), 474(A)(13), and 645(A)(9),"

5 AMENDMENT NO. 2

6 On page 1, line 4, after "Hospitals" and before "the secretary" delete "and" and insert in lieu
7 thereof a comma ","

8 AMENDMENT NO. 3

9 On page 1, line 5, after "Services" and before the semicolon ";" insert a comma "," and "the
10 state superintendent of education, and the State Board of Elementary and Secondary
11 Education"

12 AMENDMENT NO. 4

13 On page 1, at the end of line 5, change "the secretaries of" to "these entities"

14 AMENDMENT NO. 5

15 On page 1, at the beginning of line 6, delete "these departments"

16 AMENDMENT NO. 6

17 On page 1, at the beginning of line 7, delete "departmental organization" and insert in lieu
18 thereof "organizational matters"

19 AMENDMENT NO. 7

20 On page 1, line 8 after "information;" and before "and to" insert "to provide for technical
21 corrections;"

22 AMENDMENT NO. 8

23 On page 1, between lines 9 and 10, insert the following:

24 "Section 1. R.S. 17:7(22) is hereby amended and reenacted and R.S. 17:7(33) is
25 hereby enacted to read as follows:

26 §7. Duties, functions, and responsibilities of board
27 In addition to the authorities granted by R.S. 17:6 and any powers, duties, and
28 responsibilities vested by any other applicable laws, the board shall:

29 * * *

1 (22) Annually submit to each member of the legislature at the time of
2 publication an electronic copy of the state, district, school, and parent-level progress
3 profiles as required by R.S. 17:3912. Upon request, the board shall provide such
4 profiles to any legislator in the form of a paper report.

5 * * *

6 (33)(a) On an annual basis, provide all of the following information to the
7 legislature no later than thirty days prior to the convening of each regular session:

8 (i) A full organizational chart for the board which is current as of the date of
9 submission to the legislature and which shows each staff position, whether filled or
10 vacant, that comprises the board.

11 (ii) The current salary of the person occupying each filled position shown on
12 the organizational chart.

13 (b) The board may submit the report required by this Paragraph in electronic
14 format, and is further authorized, but is not required, to submit the report at the time
15 of submission to the legislature of the progress profiles required by Paragraph (22)
16 of this Section."

17 AMENDMENT NO. 9

18 On page 1, at the beginning of line 10, delete "Section 1. R.S. 36:254(A)(15) and
19 474(A)(13)" and insert in lieu thereof "Section 2. R.S. 36:254(A)(15), 474(A)(13), and
20 645(A)(9)"

21 AMENDMENT NO. 10

22 On page 2, after line 27, insert the following:

23 "§645. Powers and duties of state superintendent of education
24 A. In addition to the functions, powers, and duties otherwise vested in the
25 state superintendent by law, he shall:

26 * * *

27 (9)(a) On an annual basis, provide all of the following information to the
28 legislature no later than thirty days prior to the convening of each regular session:

29 (i) A full organizational chart for the department which is current as of the
30 date of submission to the legislature and which shows each staff position, whether
31 filled or vacant, that comprises the department.

32 (ii) The current salary of the person occupying each filled position shown on
33 the organizational chart.

34 (b) The state superintendent may submit the report required by this
35 Paragraph in electronic format, and is further authorized, but is not required, to
36 submit the report at the time of submission of the annual report required by
37 Paragraph (6) of this Subsection.
