2 On page 1, line 11, after "H." insert "(1)"

4 On page 1, line 13, after "R.S. 49:214.2(4)" delete the period "." and insert a comma "," and
5 the following:

6 "consistent with the Oil Pollution Act of 1990 and the Oil Spill Prevention
7 and Response Act, R.S. 30:2451 et seq."

8 AMENDMENT NO. 3

9 On page 1, line 19, after "Act" delete the period "." and insert the following:

10 "and shall be submitted to the House Committee on Natural Resources and
11 Environment and the Senate Committee on Natural Resources for oversight."

12 AMENDMENT NO. 4

13 On page 2, line 1, change "(1)" to "(a)"

14 AMENDMENT NO. 5

15 On page 2, line 3, after "instrument." delete the remainder of the line and delete line 4 in its
16 entity and on line 5, delete "R.S. 30:2451 et seq."

18 On page 2, line 10, delete "or developed"

19 AMENDMENT NO. 7

20 On page 2, line 13, change "(2)" to "(b)"

9 AMENDMENT NO. 15

10 On page 3, between lines 4 and 5, insert the following:

11 "(2) Neither the state nor any state agency may act as a natural
12 resource damage restoration bank sponsor under the provisions of this
13 Subsection. For the purposes of this Subsection, a "bank sponsor" is a person
14 or entity responsible for developing and operating a natural resource damage
15 restoration bank."

16 AMENDMENT NO. 16

17 On page 3, line 6, after "areas." insert the following:

18 "The compensation schedule shall be adopted under the provisions of the
19 Administrative Procedure Act and submitted to the House Committee on
20 Natural Resources and Environment and the Senate Committee on Natural
21 Resources for oversight."

22 AMENDMENT NO. 17

23 On page 4, after line 6, add the following:

24 "J. The board shall submit to the House Committee on Natural
25 Resources and Environment and the Senate Committee on Natural Resources
26 by January 15th of each calendar year a report listing each restoration bank
27 certified under the provisions of Subsection H of this Section, including the
28 names of the principals involved in the bank, every restoration credit traded
29 over the past twelve months, and the two parties between whom the credits
30 were traded."
