5 R.S. 25:941, Chapter 27 of Title 25 of the Louisiana Revised Statutes of  
6 1950, comprised of R.S. 25:1231 through 1237, Chapter 27-A of Title 25 of  
7 the Louisiana Revised Statutes of 1950, comprised of R.S. 25:1238.1 through  
8 1238.7, Chapter 27-D of Title 33 of the Louisiana Revised Statutes of 1950,  
9 comprised of R.S. 33:9039.51 through 9039.6, Part IV of Chapter 6 of Title

15 AMENDMENT NO. 2

16 On page 2, delete lines 5 and 6, and insert the following:

18 "Boards, Commissions, and Like Entities, State of Louisiana, Annual Report  
19 to the Legislature, Fiscal Year Ended June 30, 2015, Issued April 6, 2016."  
20 It is the intent of the legislature to abolish"

21 AMENDMENT NO. 3

22 On page 3, delete line 20, and insert the following:

23 "Section 4. Subpart B-1 of Part I of Chapter 1 of Title 17 of the Louisiana  
24 Revised Statutes of 1950, comprised of R.S. 17:31 through 33, is hereby  
25 repealed in its entirety."

26 AMENDMENT NO. 4

29 1950, comprised of R.S. 33:9039.51 through 9039.56, is hereby repealed in  
30 its entirety."
