COURTS: Requests the Louisiana State Law Institute to study issues regarding contempt of court

A CONCURRENT RESOLUTION

| 7 | WHEREAS, Louisiana has a presumption in favor of open court proceedings; and |
| 8 | WHEREAS, contempt of court proceedings are open to the public except in limited |
| 9 | circumstances where certain persons, including children and crime victims, require |
| 10 | protection from the additional intrusion that open court proceedings present; and |
| 11 | WHEREAS, there is a need to balance the public interest in open court proceedings |
| 12 | with the need to protect certain individuals from such intrusion. |
| 13 | THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby |
| 14 | urge and request the Louisiana State Law Institute to examine and analyze the applicable |
| 15 | laws for open court proceedings in Louisiana, to study the applicable laws regarding |
| 16 | contempt of court proceedings, and to make recommendations relative to the need for |
| 17 | changes to Louisiana law with respect to whether contempt of court proceedings must be |
| 18 | held in open court. |
| 19 | BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall also make |
| 20 | recommendations relative to exceptions and exclusions to the conducting of contempt |
| 21 | proceedings in open court. |

BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall submit

- 2 a written report of its findings and recommendations to the House Judiciary Committee and
- 3 the Senate Committee on Judiciary C no later than sixty days prior to the 2018 Regular
- 4 Session of the Legislature of Louisiana.
- 5 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
- 6 to the director of the Louisiana State Law Institute.
