# BY REPRESENTATIVES HOFFMANN, BAGLEY, COX, HORTON, JACKSON, AND POPE

## ABORTION: Requests a study and report by the Dept. of Health and Hospitals concerning the possibility of reversing the effects of an abortion induced with drugs or chemicals

1	A CONCURRENT RESOLUTION		
2	To urge and request the Department of Health and Hospitals to study whether the effects of		
3	an abortion induced with drugs or chemicals can be reversed, and to report findings		
4	and recommendations concerning this matter to the legislative committees on health		
5	and welfare.		
6	WHEREAS, news reports published in February of 2015 indicated that Dr. George		
7	Delgado, medical director at Culture of Life Family Health Care in San Diego, California,		
8	had developed and successfully implemented a method of reversing what was thought to be		
9	the inevitably fatal effect of the RU-486 abortion pill; and		
10	WHEREAS, in March of 2015, Arizona became the first U.S. state to enact a law		
11	requiring physicians who perform medication-induced abortions to tell women that the		
12	abortion procedure may be reversible; and		
13	WHEREAS, implementation of these new requirements of physicians who perform		
14	abortions in Arizona has been delayed pending a ruling by the federal courts on the law		
15	establishing the requirements; and		
16	WHEREAS, it is the longstanding policy of this state to protect the right to life of		
17	unborn children from the time of conception by prohibiting abortion impermissible only		
18	because of the decisions of the United States Supreme Court; and		
19	WHEREAS, while enactment of a requirement for doctors who perform medication-		
20	induced abortions to tell women that the abortion procedure may be reversible would be		
21	consistent with the pro-life values of this state, establishing such a requirement would be		
22	prudent only if the scientific basis of the abortion reversal method is sound.		

1	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
2	urge and request the Department of Health and Hospitals to study whether the effects of an
3	abortion induced with drugs or chemicals can be reversed.
4	BE IT FURTHER RESOLVED that the Department of Health and Hospitals shall
5	develop findings and recommendations concerning whether the effects of an abortion
6	induced with drugs or chemicals can be reversed, and shall submit such findings and
7	recommendations in the form of a written report to the House Committee on Health and
8	Welfare and the Senate Committee on Health and Welfare no later than thirty days prior to
9	the convening of the 2017 Regular Session of the Legislature.
10	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the

11 secretary of the Department of Health and Hospitals.
