HOUSE BILLS ON FINAL PASSAGE - [2 items]

1. **HB87** **ANDERS** **TAX/INSURANCE PREMIUM** Reduces the amount of the insurance premium tax for certain Louisiana investments (Item #6)
2. **HB111** **MARCELLE** **FUNDS/FUNDING** To eliminate the Debt Recovery Fund (Item #7)

HRs AND HCRs FINAL CONSIDERATION - NOTICE GIVEN - [1 items]

1. **HCR4** **JAY MORRIS** **TAX/SALES-USE-EXEMPT** Suspends various exemptions as to the 2%, 1%, and 0.97% state sales and use tax levies (Item #36)

1. **HB5** **LEGER** **TAX CREDITS** Increases the amount of the earned income tax credit (Item #26)

3. **HB19** **JAMES** **TAX/CORP FRANCHISE** Provides relative to the entities to which corporate franchise tax applies (Item #28)

6. **HB27** **COX** **TAX/ALCOHOLIC BEVERAGE** Increases the excise tax levied on certain alcoholic beverages (Item #20)
7. **HB28** **COX** **TAX/ALCOHOLIC BEVERAGE** Reduces the amount of the discount for accurately reporting and remitting excise taxes on alcoholic beverages and beer (Item #23)
8. **HB32** **LEGER** **TAX/INCOME TAX** Reduces the rates for purposes of calculating the tax on the taxable income of individuals (Items #3 and 19)
9. **HB33** **LEGER** **TAX/INCOME TAX** Reduces the amount of the individual income tax deduction for excess federal itemized personal deductions (Item #18)
10. **HB34** **LEGER** **TAX/INCOME TAX** Changes the middle and upper income tax brackets for purposes of calculating the individual income tax (Item #3)
11. **HB46** **JAMES** **TAX CREDITS** Reduces the amount of certain ad valorem tax credits and provides for the carry forward rather than the refund of a certain portion of excess credit amounts (Item #31)

12. **HB47** **JAMES** **TAX CREDITS** Reduces the amount of certain ad valorem tax credits and provides for the carryforward rather than the refund of a certain portion of excess credit amounts (Item #31)
13. **HB61** **JAY MORRIS** **TAX/SALES & USE** Dedicates the avails of the existing one percent state sales and use tax to the Stability in Higher Education Fund and provides with respect to the extent of that tax base for purposes of monies available for deposit into the fund (Items #7 and 36)
14. **HB64** **MONTOUCET** **TAX/SALES-USE, ST-EXEMPT** Provides for the extent of the state sales and use tax exemption for business utilities (Items #9 and 36)
15. **HB71** **BARRAS** **TAX CREDITS** Reduces the amount of certain Enterprise Zone tax credits and removes certain hotels from eligibility (Item #27)
16. **HB75** **STOKES** **TAX/INCOME TAX** Changes the rates and brackets for purposes of calculating individual income tax liability and eliminates certain deductions (Item #3)
17. **HB76** **STOKES** **TAX/INCOME TAX** (Constitutional Amendment) Eliminates the income tax deduction for federal income taxes paid for purposes of computing individual and corporate income taxes and references to the maximum amount of individual income tax rates and brackets (Item #3)
18. **HB78** **IVEY** **TAX/INCOME TAX** (Constitutional Amendment) Eliminates the income tax deduction for federal income taxes paid and provides for the maximum rate for individual income tax (Items #2, 3, 17, and 19)
19. **HB79** **IVEY** **TAX/INCOME TAX** Repeals the state income tax deduction for federal income taxes paid for purposes of calculating corporate income taxes (Item #17)
20. **HB80** **STOKES** **TAX/INCOME TAX** Repeals the state income tax deduction for federal income taxes paid for purposes of calculating individual and corporate income taxes (Item #17)
21. **HB81** **THIBAUT** **TAX/SALES & USE** (Constitutional Amendment) Repeals certain state sales and use tax exemptions (Items #16 and 36)
22. **HB84** **JACKSON** **TAX/SALES-USE-EXEMPT** (Constitutional Amendment) Removes the prohibition against levying a state sales and use tax on the sale of gasoline (Item #36)
23. **HB101** **JACKSON** **TAX/SALES-USE, STATE** Provides for the extent of applicability of various exclusions and exemptions from state sales and use tax (Item #36)
24. **HB103** **IVEY** **TAX/CORP INCOME** Provides relative to the rate of corporate income tax (Items #3 and 19)
