Senate Concurrent Resolutions 3rd Reading and Final Passage

SCR 6 ALLAIN TAX/AD VALOREM
Establishes a task force to study ad valorem taxes that are offset by state tax credits.

SCR 8 MORRELL TAX/INCOME/CORPORATE
Clarifies the intent of the Legislature that Act 108 of the 2015 Regular Session is to apply prospectively only.

Senate Bills 3rd Reading and Final Passage

SB 6 MORRELL TAX/AD VALOREM
Provides for the reduction of the amount of certain ad valorem tax credits and provides for the carryforward rather than the refund of a certain portion of excess credit amounts. (gov sig)

SB 18 MORRELL TAX EXEMPTIONS
Provides relative to sales and use tax exemption for rental or purchase of airplanes or airplane equipment and parts by Louisiana domiciled commuter airlines. (Item #36)(gov sig)

SB 19 MORRELL TAX EXEMPTIONS
Provides relative to the sales and use tax exemption for antique airplanes held by private collectors and not used for commercial purposes. (Item #36)(gov sig)

SB 21 MORRELL TAX EXEMPTIONS
Includes numismatic coins and bullion in the definition of tangible personal property subject to sales and use tax. (Item #36)(gov sig)

SB 22 MORRELL TAX EXEMPTIONS
Modifies the sales and use tax exemption for domed stadium facilities, baseball facilities, and other publicly owned facilities. (Item #36)(gov sig)

SB 3 LAFLEUR ECONOMIC DEVELOPMENT
Provides relative to enterprise zone requirements, incentives, and effectiveness. (Item #27)(gov sig)

SB 15 MORRELL TAX/TAXATION
Provides relative to the application of refundable tax credits. (Item #26)(gov sig)

SB 5 LAFLEUR TAX/TAXATION
Provides for the suspension of Louisiana Citizens Property Insurance Corporation assessment income tax credit. (gov sig)

HB 7 JACKSON TAX/CORP INCOME-EXEMPT
Provides relative to corporate income exclusions for dividend income from certain banking institutions (Item #15)

HB 30 LEGER TAX/SALES & USE
Provides for the collection of sales and use taxes due on sales made in Louisiana by a remote dealer (Item #30)

HB 59 MORENO TAX/SALES-USE, STATE
Provides relative to imposition of the state sales and use tax on hotels (Items #9 and 30)

HB 20 BROADWATER TAX/CORP INCOME
Provides relative to the net operating loss deduction for corporate income tax (Item #5)

| HB | 29 | LEGER | TAX/CORP INCOME | Establishes a flat rate for purposes of calculating corporation income tax liability (Item #3) |
| HB | 31 | LEGER | TAX/INCOME TAX | (Constitutional Amendment) Eliminates the income tax deduction for federal income taxes paid for purposes of calculating corporate income tax liability (Items #2 and 17) |
| HB | 43 | WHITE, MALINDA | TAX/SALES & USE | Provides for the amount of vendors compensation authorized as compensation for the collection and remittance of state sales and use taxes (Item #21) |
| HB | 54 | BROADWATER | TAX/SALES & USE | Requires the advance payment of sales tax (Item #35) |
| HB | 55 | LEGER | TAX/INCOME TAX | Requires that certain deductible items be added-back on certain corporate income tax returns (Item #5) |
| HB | 72 | SHADOIN | TAX/SALES-USE, STATE | Increases the state sales tax on telecommunications services (Item #24) |
| HB | 95 | LEGER | TAX/INCOME TAX | Repeals the state income tax deduction for federal income taxes paid for purposes of calculating corporate income taxes (Item #17) |
| HB | 39 | STOKES | TAX/EXCISE | Levies an automobile rental tax (Item #25) |
| HB | 57 | STOKES | TAX CREDITS | Repeals three-year sunset on certain eligibility requirements relative to the income tax credit for net taxes paid to other states (Item #13) |
| HB | 99 | STOKES | TAX/CORP INCOME | Provides relative to the apportionment ratio for purposes of computing corporate income tax (Item #5) |
| HB | 116 | IVEY | TAX/CORP INCOME | Provides relative to loss years for purposes of the net operating loss deduction for corporate income tax (Item #5) |
