Provides relative to exemptions from the requirements for school instructional time under certain circumstances

HB 75 MIGUEZ VITAL STATS/DEATH CERT
Provides with respect to copies of death certificates

HB 161 SEABAUGH CRIME
Provides certain exceptions to the prohibition on wearing hoods, masks, and other facial disguises in public places

HB 162 SHADOIN CRIME/FELONIES
Prohibits the filing of a false lien against state officers and state employees

HB 233 THOMAS INSURANCE/SURPLUS LINE
Provides relative to filing requirements for surplus lines insurers

HB 286 SMITH, P. CRIMINAL/RESTITUTION
Provides for the payment of restitution to the Crime Victims Reparations Fund in certain cases

HB 287 TALBOT INSURANCE
Provides for the return of unearned premium and notice of claim payments to the mortgagee

HB 289 THOMAS INSURANCE
Requires risk-bearing entities to provide certain contact information to the commissioner of insurance

HB 295 BROWN, CHAD GAMBLING/VIDEO POKER
Provides relative to the forms of payment a video draw poker device accepts

HB 308 MCFARLAND ETHICS/NEPOTISM
Allows the continued employment of a cadet or graduate of the state police training academy in the classified state police service under certain circumstances

HB 378 ANDERS INSURERS/GUARANTY ASSNS
Provides for exclusion from guaranty fund coverage for a person acquiring rights to receive payments through a "structured settlement factoring transaction"

HB 524 SCHRODER CIVIL/DISCOVERY
Provides relative to the stay of discovery in certain proceedings

HB 525 SEABAUGH LIABILITY/CIVIL
Provides for liability for violation of certain federal detainer orders under certain circumstances

HB 560 HUNTER CIVIL/PROCEDURE
Provides with respect to legislative continuance

- SB 128 MILKOVICH CRIME/PUNISHMENT
Prohibits cutting, resection, excision, harvesting, or removal of a body part, organ, or tissue of an aborted unborn child for sale, commerce, transport, research, or profit. (gov sig)
- SB 129 ALLAIN SERVITUDES
Provides relative to compensation and indemnity for right and servitude of passage on certain waterways. (8/1/17)
- SB 142 CLAITOR CRIMINAL JUSTICE
Eliminates the death penalty. (8/1/17)
- SB 146 CLAITOR CRIME/PUNISHMENT
Provides relative to the Habitual Offender Law. (8/1/17)
- SB 151 WHITE, BODI HOMELAND SECURITY
Provides for the Emergency Management Assistance Compact. (gov sig)
- SB 185 LUNEAU CIVIL PROCEDURE
Provides relative to physical or mental examinations of certain persons. (8/1/17)
- SB 212 SMITH, G. LAW ENFORCEMENT
Provides relative to peace officer training requirements. (8/1/17)
- SB 36 MARTINY HOSPITALS
Provides relative to the use of employment contracts in hospital service districts. (8/1/17)
- SB 38 MORRELL COUNSELING/GUIDANCE
Provides with respect to mental health counselors. (gov sig)
- SB 39 BOUDREAUX HEALTH/HOSPITALS DEPT
Provides relative to the Louisiana State Board of Medical Examiners. (gov sig)
- SB 58 MILLS HEALTH SERVICES
Provides relative to the statewide human services districts and authorities. (gov sig)
- SB 219 FANNIN HOSPITALS
Provides relative to certain hospital service districts. (8/1/17)
- SB 224 PETERSON HEALTH SERVICES
Provides relative to the Health Education Authority of Louisiana. (gov sig)

- SB 11 PEACOCK RETIREMENT SYSTEMS
Provides for the incorporation of the Louisiana School Employees' Retirement System into the Teachers' Retirement System of Louisiana. (7/1/17)
- SB 25 MORRELL TAX/INCOME/PERSONAL
Sunsets the individual income tax education credit. (gov sig)
- SB 26 MORRELL TAX EXEMPTIONS
Constitutional amendment to prohibit contracts under the industrial property tax exemption program from exempting millages related to school funding. (2/3 - CA13s1(A))
- SB 27 MORRELL TAX EXEMPTIONS
Constitutional amendment to exempt diapers and feminine hygiene products from state sales and use tax. (2/3 - CA13s1(A))
- SB 33 MORRELL TAX/TAXATION
Eliminates sunset provision on credit for taxes paid in other states. (gov sig)
- SB 48 MORRELL TAX/TAXATION
Provides for the termination of the credit for purchase of qualified recycling equipment or service contracts. (gov sig)
- SB 61 ALLAIN TAX/AD VALOREM
Constitutional amendment to authorize local economic development authorities or districts to enter into contracts to exempt offshore vessels from ad valorem taxation. (2/3 - CA13s1(A))

Creates and provides for Louisiana Educational Workforce Training Fund to provide opportunities for educational training in the Louisiana Community and Technical College System. (gov sig)

Provides for approval of rules and regulations of a game and fish commission. (8/1/17)
- SB 148 CHABERT PORTS/HARBORS/TERMINALS
Creates the Waterway Dredging and Deepening Priority Program. (7/1/17)
- SB 174 MORRELL TAX/TAXATION
Provides for a deduction for individual and corporate income tax for certain disaster payments. (gov sig)
- SB 175 MORRELL TAX/INCOME/PERSONAL
Provides for a deduction for certain casualty losses arising from a major disaster. (gov sig)
