HRs AND HCRs FINAL CONSIDERATION - [5 items]

1. **HR36** **MAGEE** **INSURANCE COMMISSIONER** Requests the House Committee on Insurance to study and make recommendations regarding the effects of making the commissioner of insurance an appointed position
2. **HR42** **GREGORY MILLER** **MENTAL HEALTH** Requests the La. Department of Health to seek approval of a Medicaid waiver authorizing reimbursement for inpatient treatment of serious mental illness
3. **HCR25** **SCHEXNAYDER** **LEGISLATIVE FISCAL OFF** Provides for the election of the legislative fiscal officer of the Legislature of Louisiana
4. **HCR26** **BROWN** **INSURANCE/HEALTH** Requests a joint subcommittee of the House Committee on Insurance and Senate Committee on Insurance to undertake a study to make recommendations for proposed legislation relative to balance or surprise billing in Louisiana
5. **HCR27** **HILFERTY** **MENTAL HEALTH** Requests a study by the respective legislative committees to study the rights of caregivers and the establishment of a "caregivers' bill of rights" for family members, legal guardians, and other persons who provide care for persons with serious mental illness

SENATE CONCURRENT RESOLUTIONS FINAL CONSIDERATION - [3 items]

1. **SCR12** **WARD** **COURTS** Creates the Drug and Specialty Courts Commission.
2. **SCR20** **CATHEY** **EDUCATION DEPARTMENT** Requests the Department of Education to assist certain public school boards to enter into cooperative agreements for the provision of essential services.
3. **SCR22** **TROY CARTER** **CONGRESS** Memorializes Congress to extend the certification for an 8(a) business by one additional year if the business was certified by January 1, 2020.

HOUSE BILLS TO BE CONCURRED IN - [2 items]

1. **HB4** **MAGEE** **TAX CREDITS** Extends the date for eligible expenses to qualify for the tax credit for the rehabilitation of historic structures and extends the effectiveness of the credit (Item #19)
2. **HB37** **LANCE HARRIS** **REVENUE DEPARTMENT** Requires the Department of Revenue to waive penalties and interest for certain taxpayers for tax years 2019 and 2020 (Item #29)

SENATE BILLS ON FINAL PASSAGE - [4 items]

1. **SB11** **FESI** **FRAUD** Provides relative to civil liability and certain actions for nullity involving fraud. (Item #40) (See Act)
2. **SB12** **FESI** **UNCLAIMED PROPERTY** Constitutional amendment to dedicate unclaimed property funds and to create the Louisiana Unclaimed Property Permanent Trust Fund. (2/3 - CA13s1(A)) (Item #10) (7/1/21)
3. **SB18** **FESI** **FUNDS/FUNDING** Dedication of unclaimed property funds and creation of Louisiana Unclaimed Property Permanent Trust Fund. (Item #10) (See Act)
4. **SB19** **PEACOCK** **FUNDS/FUNDING** Provides for investment authority of the Treasurer for the Millennium Trust, the Rockefeller Wildlife Refuge Trust and Protection Fund, and the Russell Sage or Marsh Island Trust Fund. (Item #10) (7/1/20)
