SB 517 FIELDS WORKERS' COMPENSATION
Provides for continuation of the weekly death benefit for the surviving spouse of a law enforcement officer upon remarriage. (8/1/20)

SR 38 JACKSON CONDOLENCES
Expresses condolences upon the death of Reverend Dr. Harry Blake.

SR 39 HEWITT SENATE
Amends Senate rules to permit members to vote via video or other electronic means during a declared emergency.

SR 40 BARROW CONDOLENCES
Expresses condolences upon the passing of Ludia "Bea" Manogin Thomas.

SCR 62 MILLIGAN SCHOOLS
Requests the State Board of Elementary and Secondary Education to implement a traumatic injury response program in all public schools.

Allows each recognized political party to determine the composition of its state central committee. (gov sig)

SB 354 MCMATH PUBLIC SFTY/CORRECT DEPT
Provides relative to the photo identification issued to an offender prior to his release. (8/1/20)

SB 378 JOHNS GAMING
Provides for a proposition election to determine whether sports wagering activities and operations will be permitted in a parish. (6/10/20)

SB 395 CLOUD ADVERTISING
Provides relative to false, misleading, or deceptive advertising. (8/1/20)

SB 397 BERNARD VOTERS/VOTING
Provides relative to counting absentee and early voting ballots. (gov sig)

SB 406 MIZELL TELECOMMUNICATIONS
Provides for rural access to broadband high-speed Internet service. (8/1/20)

SB 422 BERNARD VOTERS/VOTING
Provides for the reinspection of voting machines and recounting of absentee by mail and early voting ballots. (gov sig)

SB 426 BARROW INSURANCE CLAIMS
Requires health insurance coverage for COVID-19 (Coronavirus) diagnostic testing. (gov sig)

SB 433 MIZELL CRIMINAL PROCEDURE
Provides that a mandatory reporter of child abuse has cause to suspect abuse if a child under the age of thirteen is pregnant. (gov sig)

SB 434 MIZELL CRIMINAL JUSTICE
Provides for immunity from prosecution and post-conviction relief for victims of human trafficking. (gov sig)

SB 439 ABRAHAM LIABILITY
Limits liability of a nonprofit organization or employee for the disclosure of certain information. (8/1/20)

- SB 398 FOIL HOMELAND SECURITY
Provides for qualifications of volunteers to cyber response and recovery support efforts with the Governor's Office of Homeland Security and Emergency Preparedness. (8/1/20)
- SB 407 FOIL CRIMINAL JUSTICE
Provides relative to the post-conviction veterans mentor program. (8/1/20)
- SB 418 TALBOT LIABILITY INSURANCE
Enacts the Omnibus Premium Reduction Act of 2020. (1/1/21)
- SB 435 ABRAHAM LIABILITY
Provides relative to certain immunity from civil liability during state of emergencies. (gov sig)
- SB 452 FOIL LOTTERIES
Provides for the amount of gross revenue the Lottery Corporation is to annually transfer to the state treasury. (8/1/20)
- SB 489 MCMATH LIABILITY
Provides relative to limitation of liability of governmental entities which require its employees to work during a declared state of emergency. (gov sig)
- SB 505 SMITH, G. DOMESTIC VIOLENCE
Provides for a temporary restraining order upon application by a peace officer under certain circumstances. (8/1/20)

- SB 67 MILLS, FRED HEALTH CARE
Provides for the repeal of certain inactive or obsolete laws. (8/1/20)
- SB 69 BOUDREAUX SECRETARY OF STATE
Authorizes the secretary of state to refer matters involving the damaging, altering, tampering, or of falsifying records to certain agencies for investigation. (gov sig)
- SB 105 PEACOCK LEGIS POWERS/FUNCTIONS
Designates the Gulf Fritillary as the official state butterfly. (8/1/20)
- SB 168 MILLS, FRED WATER QUALITY
Creates and provides for the Community Drinking Water Infrastructure Sustainability Act. (8/1/20)
