3. **HB615** **FREIBERG** **TAX/GASOLINE TAX** Adjusts the amount of excise tax levied on gasoline, diesel, and special fuels and levies new taxes on gasoline, diesel, special fuels, and electric and hybrid vehicles

2. **HB376** **IVEY** **TAX/INCOME TAX** Provides for a flat tax rate for purposes of calculating income tax for individuals, estates, and trusts and modifies income tax credits and deductions
3. **HB370** **IVEY** **TAX/AD VALOREM-EXEMPTION** (Constitutional Amendment) Establishes certain property tax exemptions for capital investment projects
4. **HB464** **IVEY** **TAX/AD VALOREM-EXEMPTION** Provides for ad valorem tax exemptions for certain capital investment projects
