SB 388 HEWITT ABORTION
Prohibits the sale of certain abortion inducing drugs without a prescription and creates the crime of criminal induced chemical abortion. (8/1/22)

SB 132 MILLIGAN SUNSET LAW
Re-creates the Governor's Office of Homeland Security and Emergency Preparedness. (6/30/22)

SB 234 JACKSON JUVENILE JUSTICE
Constitutional amendment to allow adult prosecution and enhanced penalties against juveniles in correctional facilities who commit assault or battery against an employee or juvenile. (2/3 - CA13s1(A))

SB 304 CATHEY CRIME/PUNISHMENT
Provides relative to commutation of a prison sentence for good behavior. (gov sig)

SB 359 JACKSON SEIZURES/SALES
Provides for civil forfeiture reform. (8/1/22)

SB 379 PEACOCK WEAPONS
Prohibits possession of firearms, ammunition, or electric weapons or devices by certain felons. (8/1/22)

SB 104 MIZELL HEALTH CARE
Provides relative to telephone access in outpatient abortion facilities. (gov sig)

SB 134 TALBOT INSURANCE POLICIES
Provides for the presumption of coverage for certain claims subsequent to a catastrophic event. (1/1/23)

SB 147 MIZELL SEX OFFENSES
Provides for sexual assault survivors to have access to certain documents from the forensic medical exam. (8/1/22)

SB 199 SMITH, G. VOTERS/VOTING
Constitutional amendment to ensure the right to free and equal elections. (2/3 - CA13s1(A))

SB 213 LUNEAU BEHAVIORAL HEALTH
Provides relative to specialized behavioral health rehabilitation services in the Louisiana medical assistance program. (gov sig)

SB 286 LUNEAU OCCUPATIONAL THERAPISTS
Provides for licensure and qualifications of massage therapists. (8/1/22)

SB 352 FIELDS COMMERCIAL REGULATIONS
Requires utility providers to issue a credit to customers who experience an outage of service for more than 24 hours. (8/1/22)

SB 353 FIELDS COURTS
Provides relative to the judgeships of the second district of the First Circuit Court of Appeal. (2/3 - CA5s9) (gov sig)

SB 442 WARD CONSUMERS/PROTECTION
Provides relative to certain third-party sellers on the online marketplace. (1/1/23)

SB 478 BERNARD PUBLIC RECORDS
Provides relative to the public records law. (8/1/22)

SB 484 LUNEAU CIVIL PROCEDURE
Authorizes a commercial insurer to select a forum or venue in a policy form. (8/1/22)
