## House Bills 3rd Reading and Final Passage

TAX/INCOME TAX HB 1 EMERSON

> Provides for a flat rate for purposes of calculating income tax for individuals, estates, and trusts, increases the standard deduction, and modifies or repeals certain income tax deductions and credits

(Item #5 and 6)

2 EMERSON TAX/CORP INCOME HB

> Provides for a flat rate for purposes of calculating corporate income tax and terminates certain corporate income tax exemptions, deductions, and credits (Item #4)

**EMERSON** TAX/CORP FRANCHISE HB

> Repeals the corporation franchise tax and limits eligibility of certain credits to be claimed against corporation franchise tax (Item #3)

4 MCFARLAND APPROPRIATIONS/SUPPLEML HB

Makes supplemental appropriations for Fiscal Year 2024-2025 (Items #18, 21, and 23)

5 BACALA TEACHERS/SALARY HB

> Requires school systems to provide a salary increase for teachers and other school employees using savings attributable to the state's payment of certain unfunded accrued liability of the Teachers' Retirement System of Louisiana (Item #2)

HB **ELECTIONS/SPECIAL** 

> Calls a special statewide election on March 29, 2025, for submitting proposed constitutional amendments to the state's electors (Item #22)

**EMERSON FUNDS/FUNDING** HB

(Constitutional Amendment) Revises Article VII of the Constitution of La. (Items #1, 2, 7, and 14)

HB 8 BRASS TAX/SALES & USE

Levies sales and use taxes on certain digital products and services (Items #8 and 13)

10 WRIGHT HB TAX/SALES & USE

> Provides for the rate of the state sales and use tax and provides for the exemptions, exclusions, credits, and rebates claimed against sales and use taxes (Item #8)

TAX/AD VALOREM TAX HB DESHOTEL

> Provides for the homestead exemption, special assessment level, and other property tax exemptions for purposes of determining ad valorem taxation of certain property (Items #1 and 10)

HB 12 DESHOTEL **FUNDS/FUNDING** 

Relative to finances of the state (Items #16 and 21)

**APPROPRIATIONS** HB 13 GEYMANN

Limits the amount of money that may be appropriated in a fiscal year (Item #14)

HB GEYMANN **MINERALS** 

Provides for the administration of the Oilfield Site Restoration Fund (Item #16)

HB TAX/SEVERANCE TAX

> Provides relative to severance tax on oil and gas and for dedication of certain severance tax revenues (Item #9)
