## Senate Bills Returned from House with Amendments

**CIVIL PROCEDURE** SB MILLER, G.

> Provides for legislative continuances and extensions of time for legislators and legislative employees. (Item #20) (gov sig)

## **House Bills 3rd Reading and Final Passage**

HB **EMERSON** TAX/INCOME TAX

> Provides for a flat rate for purposes of calculating income tax for individuals, estates, and trusts, increases the standard deduction, and modifies or repeals certain income tax deductions and credits (Item #5 and 6)

HB **EMERSON** TAX/CORP INCOME

> Provides for a flat rate for purposes of calculating corporate income tax and terminates certain corporate income tax exemptions, deductions, and credits (Item #4)

TAX/CORP FRANCHISE HB **EMERSON** 

Repeals the corporation franchise tax and limits eligibility of certain credits to be claimed against corporation franchise tax (Item #3)

HB **MCFARLAND** APPROPRIATIONS/SUPPLEML

Makes supplemental appropriations for Fiscal Year 2024-2025 (Items #18, 21, and 23)

HB **BACALA** TEACHERS/SALARY

> Requires school systems to provide a salary increase for teachers and other school employees using savings attributable to the state's payment of certain unfunded accrued liability of the Teachers' Retirement System of Louisiana (Item #2)

**ELECTIONS/SPECIAL** HΒ 6 BEAULLIEU

> Calls a special statewide election on March 29, 2025, for submitting proposed constitutional amendments to the state's electors (Item #22)

HB **EMERSON FUNDS/FUNDING** 

(Constitutional Amendment) Revises Article VII of the Constitution of La. (Items #1, 2, 7, and 14)

TAX/SALES & USE HB BRASS

Levies sales and use taxes on certain digital products and services (Items #8 and 13)

HB WRIGHT TAX/SALES & USE

Provides for the rate of the state sales and use tax and provides for the exemptions, exclusions, credits, and rebates claimed against sales and use taxes (Item #8)

**DESHOTEL** TAX/AD VALOREM TAX HB

> Provides for the homestead exemption, special assessment level, and other property tax exemptions for purposes of determining ad valorem taxation of certain property (Items #1 and 10)

HB DESHOTEL FUNDS/FUNDING

Relative to finances of the state (Items #16 and 21)

HB **GEYMANN APPROPRIATIONS** 

Limits the amount of money that may be appropriated in a fiscal year (Item #14)

**GEYMANN MINERALS** HB

Provides for the administration of the Oilfield Site Restoration Fund (Item #16)

TAX/SEVERANCE TAX HB 25 RISER

> Provides relative to severance tax on oil and gas and for dedication of certain severance tax revenues (Item #9)
