(3) Stakeholders, including trade and advocacy associations, individuals engaged in the daily operational practice of nursing facility care, and quality improvement organizations, shall be identified and utilized by the department to build a coordinated approach centered on collaboration, education, and practical tools.

B. The Louisiana Department of Health, through the office of aging and adult services, shall identify and develop internal subject-matter experts to support the statewide quality oversight initiative. The department may utilize such efforts as considered appropriate, including but not limited to:

(1) Data dashboards and public-facing online tools.

(2) Resident and family satisfaction surveys.

(3) Staff training plans and ongoing staff training and development.

(4) Participation in the Centers for Medicare and Medicaid Services Nursing Home Staffing Campaign.

C. The department shall submit an initial report to the Senate and House committees on health and welfare on the status of the statewide quality oversight initiative on January 1, 2028, and annually on the first of January thereafter."

§1381. Reporting requirements

A. The legislature hereby recognizes the importance of the occupational field of plumbing and the necessity of expanding recruitment, especially in the population of minority students, as the pool of licensed plumbing professionals has not grown at the same pace of need for the occupation. It is the intent of the legislature that the board increase outreach to minority students for recruitment into the occupational field of plumbing.

B. The pilot program shall be limited to four state funded projects per year, two each for the department and the office of Louisiana highway construction, and subject to the approval of the Senate and House committees on transportation, highways and public works.

B. (1) For purposes of this Section, if five or more responsive bids are received, the department shall average the bids, excluding the highest and lowest responsive bids. The department shall award the contract to the bidder whose responsive bid is closest to the average. If two or more bids are equally close,

award shall be made to the lower bid. If no bid is equal to or less than the average mean, award shall be made to the lowest responsible bidder.

(2) If less than three responsive bids are received, all bids will be rejected.

C. The provisions of this Section shall not apply to professional services.

Section 3. The provisions of this Section shall terminate March 1, 2028 unless legislatively extended."
